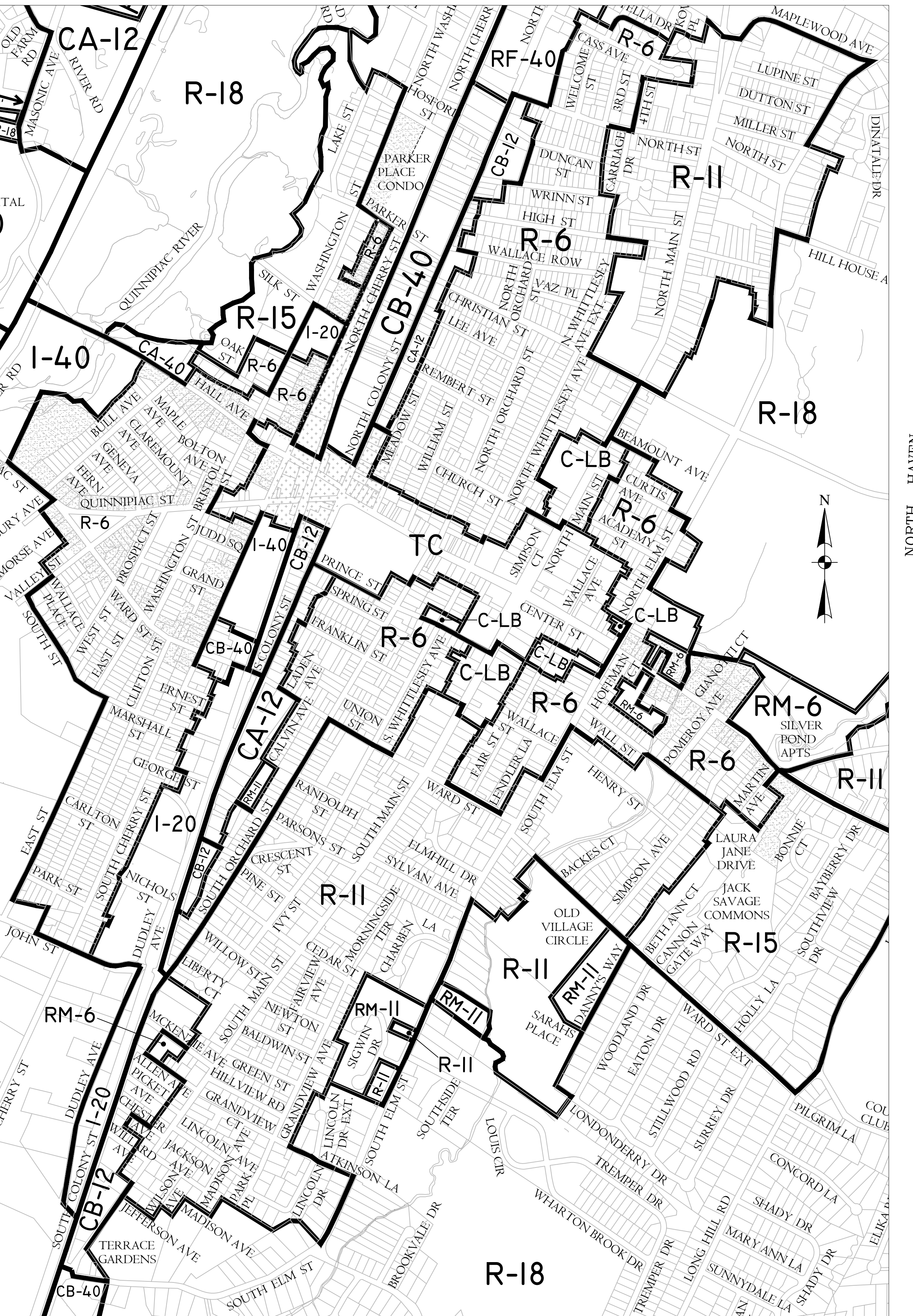


OFFICIAL ZONING MAP TOWN OF WALLINGFORD
