Mr. Hutt stated SageView was the prior advisor and noted there was little cost to the town.

Councilor Tatta questioned the wording of the memo which stated this will be in effect until 2022.

Councilor Shortell asked where we are with the replacement of Mr. Bowes. Mr. Hutt explained the list is provided to the Mayor and then Human Resources will schedule interviews.

Councilor Fishbein questioned why when we go out to bid we look for the lowest cost. Mr. Hutt stated we look for the lowest responsible bid.

There was further discussion between Mr. Hutt and Councilor Fishbein.

The Mayor stated if this fails tonight, we are without services and we need this expertise in the interim.

Councilor Fishbein asked if we could save employees this cost. The Mayor said he doesn't think we can. He went on to say we need someone assuring us what is being provided to us by Nationwide.

Mr. Hutt stated we have done everything we can to benefit our employees.

Councilor Tatta and Mr. Hutt discussed staffing in the Comptroller's office.

Councilor Morgenstein and Mr. Hutt discussed the timeline when Mr. Bowes left and the company was hired.

Councilor Testa feels we are overdue for a special meeting regarding how the pension fund is managed.

Councilor Testa, Mr. Hutt and the Mayor discussed the 457 Retirement Plan and the Pension.

Bruce Conroy, 13 Burke Heights Drive, stated the most important job in town government is not filled and everything is left undone until the position is filled. He feels we should go ahead and pass this bid.
