# **Director's Report: Kenny Michaels**

The summer registrations started. The summer playground camps will be located at Moses Y, Stevens and Mary Fritz elementary schools. Registration will begin March 14. Summer Sizzlers registration started on March 7 with a maximum of 125 participants. More than 50% full in the first two days. The preschool camps are Tiny Bubbles and Pop Shots. Registration started February 28 and all three camps are full. Kenny will have a wrap up of winter programs at next meeting. Ski Bums program had the highest number of registrations in the last eight years. Pickle ball court at Harrison Park has three high bids over the budgeted amount, to resurface and repaint the court. Kenny will discuss this with the Mayor. All the field user meetings are done for spring/summer 2022. He is hopeful that the fields will be open the third week of March. The YMCA fee waiver request came in for their summer camp. The Parks and Rec budget presentation to the mayor is Friday, March 11.
