9. Discussion and Possible Action to initiate an investigation by the Town Council into the illegal cutting down of trees in the parks of Wallingford and the removal of the wood to an illegal disposal site – Councilor Nick Economopoulos

Councilor Cervoni pointed out the characterization of the item. In reply, Councilor Economopoulos asked to remove the word 'illegal' from Item 9. Town Attorney Farrell stated that it was fine to just strike the word 'illegal', inferring that no motion was needed.

Item 9 following this request:

Discussion and Possible Action to initiate an investigation by the Town Council into the cutting down of trees in the parks of Wallingford and the removal of the wood to an disposal site – Councilor Nick Economopoulos

Assisting Councilor Economopoulos was Dana Camp, Business Integrated Technology Solutions, BITS

Councilor Economopoulos presented reasons for why he wants to initiate an investigation through the use of a PowerPoint report that included videos of various sites, photographs of locations about which he spoke and various documents that supported the information he was giving. At the conclusion of the presentation, Councilor Economopoulos stated the following motion.

(1) MOTION WAS MADE THAT THE WALLINGFORD TOWN COUNCIL CONDUCT AN INDEPENDENT INVESTIGATION OF THE WOOD DISPOSAL FROM OUR TOWN PARKS.

Councilor Economopoulos stated that if he needs to change the motion in any way to specifically judge the one that was done in January, then the dates of when it was done would need to be included. He said he has those specific dates.

Councilors expressed questions that arose during the presentation with regard to the bid document; why wood was being transported under this bid; why wood being removed at all; who determines what trees come down; was there tagging of trees; the appearance that Public Works trucks were used to transport from parks to Mangino; what is the procedure; and how do we do this?

Town Attorney Farrell read Chapter III, Section 10, Page 10 of the <u>Charter of the Town of</u> <u>Wallingford, Connecticut</u>

Section 10. Investigation The council, by a vote of at least three (3) members, shall have power to investigate any and all departments, offices and agencies of the town.

Attorney Farrell stated that he did not think the Council would have subpoena powers.

Has this ever been done; how does the town council get information?

Mayor Dickinson suggested that the Council begin with the report of the Personnel Director, Terence Sullivan. with respect to his investigation.

If allegations made, shouldn't the police investigate? Or is it civil?

Councilor Economopoulos noted that Mr. Sullivan only interviewed three (3) people when many more were on the crew and that they too should be interviewed and questioned by independent investigators. He said a lot more is involved including the supervision of Purchasing and the execution of the bid.

Mr. Mangino used town trucks on his lunch hour. This is taken directly from Mr. Sullivan's report. This makes the town liable. Corrective action could have been taken. Town employee used this to his benefit. Supervisor without knowledge of the bid specifications and of the bid requirements.

Attorney Farrell responded to the Council that they have the power to delegate to an independent investigation, and that with the findings, the Council can refer to the Police Department, if a criminal issue or refer to the Personnel Director, if a Personnel issue. Counselor Farrell warned the Council to be very careful and to not presume and in response to a question that in the end this will be a public document.

It was confirmed that Mr. Mangino's bid had been cancelled.

Councilor Fishbein said that the context of the original motion does not address the totality of the issue and needs to be broader.

Former Town Councilor, Vincent Testa, offered that it is a good idea to have an investigation and that the Council needs the cooperation of the Administration. He reiterated that the Council can make referrals to the Police Department or to the Personnel Department.

Dick Caplan, Long Hill Road, spoke about transparency and community trust. Ed Bradley recalled an earlier 1989-90 investigation when he served on the Council. Vincent Avallone said that the new ordinance has nothing to do with this issue. Dana Camp asked the Council to include an investigation regarding the August events.

Who will do the investigation? Someone not affiliated with the town. Very serious issue. People's lives and careers at stake here. Talk about selection method for an investigator – bid or RFP. Corrective action came up again.

Discussion with respect to a committee to list the basic steps to be taken.

Councilor Fishbein had earlier in the discussion offered a suggestion with different dates and then changed the dates in his amendment, which follows. He then asked Councilor Economopoulos if he accepted the amendment that he proposed. Councilor Economopoulos responded that he accepted the second amendment of Councilor Fishbein. They agreed, and Councilor Fishbein read the second amendment again.

Councilor Zandri called the vote.
