## PUBLIC HEARING

#### **RECORD OF VOTES & MINUTES**

The Public Hearing on the Budget was called to order at 6:03 P.M. in the Robert Earley Auditorium of the Wallingford Town Hall. A Moment of Silence was observed, and the Pledge of Allegiance was said. Councilors in attendance were as follows: Vincent Cervoni, Nick Economopoulos, Craig C. Fishbein, Thomas Laffin, John LeTourneau, Chairman Robert F. Parisi, Rosemary Rascati and Jason Zandri. Councilor John J. Sullivan arrived at 6:34 P.M. Mayor William W. Dickinson, Jr. and Comptroller James Bowes were also in attendance at the meeting.

## 3. Public Hearing on the Town of Wallingford Budget for FY 2012-2013

Mayor Dickinson opened the Public Hearing with comments to the residents of the Town of Wallingford. He asked, "Why have government?" He remarked that there are certain services that are needed in order for society to function in a way that is beneficial to all members of that society. He asked what services that should be provided by government and what would be a reasonable cost of those services given all the factors involved to the members of the society. He stated that the proposed budget is recommended. It has a range of services that have been provided for a long time that have allowed the community to flourish. He added that the cost of those services continue to go up. He referred to the state of the economy and in other layers of government some of which is not helpful when trying to address the needs of our community and how to deal with all of the problems and challenges associated with services and the governance of the community. He went on to say that the bare bones of the budget are that the budget totals approximately \$145,000,000 without counting utilities. It's not a small business.

Expenditures increased 2.6%; education, which is 60+% of the budget, will increase 3.2%; General Government increases 1.63%, an increase which is the first year in four years that it has increased. He said there has been a serious effort at controlling the expenses while being mindful of the difficulties of the citizenry in meeting the challenges of a poor economy. The tax increase is .76 mills, 3.01% in the mill rate, and the result is on the average, assessed property of \$191,000 that the tax increase annually is \$145.00. He said he prefers no tax increase but after close analysis if what we need and how to continue the quality of life that we enjoy in Wallingford, it is necessary.

He continued in discussing the Utilities, who offer the most essential services on a daily basis in the community. The Electric, a very central service, a very important service has a .6% rate increase, which is for a residential customer \$1.63 per month on a monthly 750kWh usage.

He stated that we need potable water to maintain public health. The number one cause of disease in the world is bad water, and we lose sight of that in this country. It is an absolute blessing to be able to turn on a faucet and receive potable water. It's an incredible gift. Water will have a 3.5% rate increase and that is \$.95 per month for a 2,200 cu ft per quarter per residential user.

Sewer is a 10.3% rate increase which is \$4.29 per month on 2,200 cu ft user of the waster water treatment. One half of the waste water increase is due to our need to reduce inflow and infiltration, meaning water that is getting into our system that is not waste water. It's storm water that increases the volumes that go through our treatment plant. At the point we reach a given level, we will have to spend tens of millions of dollars to expand the plant. It is essential that the money be put aside to allow us fix the system. He said that it is an important project and that an ordinance has been proposed and will be moving forward.

Another issue that is not in this budget is phosphorus issue coming from both the state and the federal governments which potentially mean millions of dollars for taking phosphorus out of waste water. He encouraged people to write to their representatives in Congress. For Wallingford, this could mean a \$20 million to \$60 million expenditure that we cannot afford. This is an example of the other things that are being visited upon us. We need to say no.

He stated that he believes this to be a good budget that he recommends to the Council and the public that it is something that will serve the community well. He thanked everyone for their attendance.
