Robert Gross, 114 Long Hill Road, asked about the status of the Covanta contract. He also wanted to know about the phase that follows the removal of the street trees along Center Street.

Larry Morganstein, Main Street, made comments with regard to the installation of an Rx drop box in the Town of Wallingford.

Matthew Gunter, South Main Street, introduced himself and his fiancé as new residents. He was interested the LED street lamps.

As the Public Hearing was scheduled for 7:00 P.M., Chairman Cervoni called for Item 8 to be heard.

8. Report regarding street lighting provided by the Wallingford Electric Division – Councilor Craig Fishbein and Chairman Vincent Cervoni

In attendance: Rick Hendershot, Electric Division General Manager

The Town Council received two memos from Mr. Hendershot that outlined a course of action in the reporting of and the repair of street lamps that are out. Mr. Hendershot stated that the Wallingford Electric Division will set up night-time-patrols during the months October, December and February. The patrol survey is to record street lamps that are not functioning and will likely be performed by one person, possibly a lineman and be in addition to a normal workday. He reported that 900 street lamps have been repaired; twenty-three street lamps repaired to date in September and that the back log of lamps they know about are less than ten street lamps. He said that his department learns of outages when residents call in pole numbers, and he called upon citizens to continue this practice.

Also discussed were LED lights-they are proceeding carefully as the product is rapidly changing and the price is coming down; police reporting street lamps; the complex period-lighting changeover to LED lamps.
