#### **RECORD OF VOTES & MINUTES**

The Regular Meeting of the Wallingford Town Council was called to order at 6:32 P.M. The Opening Prayer was offered by the Reverend Dean Warburton of the First Congregational Church of Wallingford. #### 5. PUBLIC QUESTION AND ANSWER PERIOD

Robert Gross, 114 Long Hill Road, asked if the public would have an opportunity to speak to Item 5A.

He also wanted to know why this subject is so secret. He asked the Mayor if he would be sharing the issues that are being negotiated. Mayor Dickinson remarked that each negotiation, Wallingford, Covanta and other towns, may be subject to FOIA. Mr. Gross expressed his concern regarding the lack of transparency.

Geno Zandri, 9 Balsam Ridge Circle, asked if the Mayor could get the open police department positions filled.

Larry Morgenstein, Main Street, thanked those Councilors who attended the Red Ribbon Week breakfast. He reminded everyone that in the last three years the *Coalition for a Better Wallingford* is aware of fifty three (53) young people in Wallingford who have died of drug overdoses.

Gina Morgenstein, Main Street, would like to see the town make a plan for moving forward. She said a ten-year plan. We need a ten-year plan. She said, "Make a plan." She also inquired about the status of the Johnson Mansion fence. Councilor LeTourneau said that the grant money ends December 31, 2014. He said that the fence will be in place within the next three (3) weeks.

Bill Comerford, 5 Broadview Drive, would like an update on the repair of the town's park benches.

- **5A.** Presentation and Discussion regarding:
  - a. The Amendment to the Municipal Solid Waste Disposal Agreement with Covanta Projects of Wallingford, L.P.

In attendance: Doreen Zaback, Resource Recovery Project Coordinator Don Roe, Program Planning

A large packet of documents was distributed to the Town Council. The packet includes the following documents:

- Summary of Contract Amendments
- 2<sup>nd</sup> Amendment to Municipal Solid Waste Disposal Agreement-pending
- 1<sup>st</sup> Amendment to Host Municipal Fee Agreement-pending
- Municipal Solid Waste Disposal Agreement between the Town of Wallingford and Covanta Project of Wallingford, 12/17/2008
- *Host Municipality Agreement, 12/17/208*
- 1<sup>st</sup> Amendment to Municipal Solid Waste Agreement, 2/1/2012

(These documents are part of the record of the meeting.)

Ms. Zaback reviewed a recent meeting when she reported to the Town Council the status of Connecticut's declining solid waste along with future trends in this area. She said that Covanta needs a conversion in going from a waste-to-energy plant to a transfer station. In accomplishing this conversion, amendments are needed to the existing contract. Ms. Zaback read the *Summary* of the Contract Amendment, followed by the key points of the 2<sup>nd</sup> Amendment to Municipal Solid Waste Disposal Agreement.

The Town Council was interested in asking questions at this point and much of what followed for the next approximately two hours was an exchange between the Council, the Mayor, Mr. Roe and Ms. Zaback. They discussed the loss of income from Covanta to the Town of Wallingford, the host town, and the five participating towns of Cheshire, Hamden, Meriden and North Haven. The amendments to the contract are thought to be the best for the town. Each town has their own contract to consider. There will be a loss of income to the town but Wallingford will gain cleaner air and water. Since trash will no longer be burned here, it lessens our liabilities. If the suggested amendments are refused, then Covanta could continue to operate however they wish since they own the property. Covanta is not going to remain as trash-to-energy. Covanta indicated that it doesn't pay to run a trash-to-energy plant. If Covanta leaves and no longer accepts trash, there is capacity in the state at locations such as Newtown, Preston, Bridgeport and Bristol. Wallingford's trash would go to Bristol, Connecticut.

The Mayor shared that during the many negotiations what was originally offered was much less than is in the amendments being discussed. He feels his agreement to be the best for the town, considering the coming change at the plant. There were payment questions and capacity of tonnage per year that the five towns must meet each year. It was stated that Wallingford currently has the best host community agreement in the State of Connecticut. Some Councilors would like to hold Covanta to the original contract and have stated that as the host community, Wallingford should be getting more than the other towns. With a transfer station, they pointed to the loss of revenue to the Water Division and to the loss of revenue to the town. The Mayor stated that you get into a whole other area when you go elsewhere with handling of flow control, having to put it out to contract and in managing the cost to the residents of town. It is multi-faceted. The Mayor said that he recommends that it is in our interest to stay in this project and to be assured of a place to take our trash.

Attorney Small said that if we do not accept this, then our position is that we presently have an enforceable agreement, and we would expect them (Covanta) to honor it. As to what they do then, she said, would remain to be seen. She said that she does not know what the other towns would do but our position remains that if we do not accept this alternative that we have an existing contract that may lead to a breach, and then we would have to examine what that means.

Chairman Cervoni announced that this item will be on the first November agenda when they will be voting and seeking public comment. Next, he moved Item 8 to be taken up.

**8.** Consider and Approve Request for Approval to utilize the Qualifications-Based Selection (QBS) procedure for a wholesale power procurement auditing consultant – Public Utilities

In attendance: George Adair, Director of Public Utilities

Mr. Adair introduced the item stating that Wallingford is now an ISO New England participant engaged in hedging activities with the help of its agent, Energy New England. We find ourselves involved in many more steps and operations than we were with our relationship with CMEEC. During the due diligence process looking at what would be entailed in this other way of doing business that we are now in, the PUC, the Mayor and in Executive Sessions there was concern that we continue that due diligence and employ an outside auditor to come in and review the manner in which the Electric Division Personnel, and anyone else in this process, to look at how those functions are carried out and to determine whether we are complying with our own policies. He said they have an energy risk management policy and a hedging policy. In addition, Energy New England have a certain number of elements that come out of the public utilities policies that they have signed off on. It is a formalized set of procedures and they have had recent occasion to practice with these policies. They aren't gathering dust. He said they are a majority of one in the state and to a certain extent in the region, and that it is unusual for a municipal utility to embark on this much self-scrutiny. Because of the importance of the tasks, the PUC and the Mayor felt this is appropriate. This is the reason for seeking this method of identifying and determining the qualifications of folks is that this is a highly specialized task. He said they will probably be contacting ACES Power Marketing because they subject themselves to this kind of audit and to get some ideas to whom we can send this solicitation. It will be publically advertised. Mr. Adair read aloud the attachment mentioned in Mr. Adair's letter. The process was discussed. Qualifications are the most important and because this is sort of groundbreaking, the cost has not come up.
