DEPARTMENT: Public Works

GENERAL DUTIES:

Performs a variety of skilled tasks in the maintenance, repair and construction of roadways, roadsides, storm and sanitary sewer lines, parks, recreation grounds and public areas; operates mechanical equipment such as trucks, graders, and other large or medium equipment requiring skill in normal operation procedures; removes snow and ice from Town roads and sidewalks; builds manholes and catch basins; lays drainage pipe and other craft operations requiring moderate skill; directs the work of others as assigned; performs aerial work when needed; performs other related work or work of a lesser grade as required.

SUPERVISION RECEIVED:

Works under the direction of Superintendent, Foreman, or other authorized supervisor.

SUPERVISION EXERCISED:

By assignment, may direct the work of one or more employees, normally of a lower grade, by assigning tasks, inspecting work or keeping equipment in working order.

KNOWLEDGE, SKILLS AND ABILITIES:

Considerable physical stamina to work under arduous conditions; thorough knowledge of processes and materials used in particular skill; ability to perform necessary manual operation of particular skill; considerable ability to operate mechanical equipment required in assigned operations; considerable knowledge of maintenance, repair and construction of highway, sewer or park and public grounds projects; ability to work long hours during storms and other emergencies; ability to direct the tasks performed by others and to establish effective relationships with others.

MINIMUM QUALIFICATIONS:

Three (3) years employment in a field related to heavy construction of which two (2) years shall have involved a special skill in equipment or manual operation \underline{OR} one (1) year of training in a skilled trade substituted for one (1) year of experience to two (2) years plus one (1) year of construction experience OR an equivalent combination of experience and training.
