## Wallingford, Connecticut 2025 Declaration of Personal Property MOTOR VEHICLE

**Filing Requirement** – This Declaration must be completed and filed with the Assessor of the municipality where the personal property is located. Declarations of Personal Property shall be made annually. Writing "Same as last year" is not acceptable.

**Penalty for late filing** – Failure to file timely will result in a penalty equal to 25% of the assessment of the personal property. This Declaration must be filed or postmarked (as defined in CGS §1-2a) no later than **November 3, 2025**.

**Extension:** The Assessor may grant a filing extension *for good cause* (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor in writing **on or before November 1, 2025**.

### Deadline to File: Monday, November 3, 2025

If you no longer own the personal property assessed in your name last year or moved the property out of this municipality, you do not need to complete the full Declaration. You must return the affidavit below to the Assessor and provide information related to the name of the new owner of the property or to where you moved the property (see the Affidavit below). Otherwise, the Assessor must assume that you still own and have failed to declare your taxable personal property.
