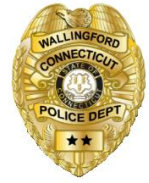

### Two Arrested in Lowe's Shoplifting

On March 16, 2023, Wallingford Police responded to Lowe's for a shoplifting in progress involving two male suspects, a driver, and a get-away vehicle. Responding officers quickly located one male suspect wearing a green jacket and a New York Yankees hat leaving the store after not paying for several items. The male initially refused to comply with officer's orders, but was quickly placed into custody. The second male suspect was arrested leaving the store a short time later without incident. The get-away driver fled in a white GMC Acadia with NY registration KBT3518 and was not located. The arrested parties are identified as 31-year-old Jalil McIntyre of 11121 180<sup>th</sup> Street, Jamaica, NY and 23-year-old Deshun Jackson of 300 Vernon Avenue, #B15 Brooklyn, NY. Through investigation, it was determined that both men have extraditable arrest warrants out of New Hampshire.

Jackson was charged with violation of Connecticut General Statutes 53a-125a- Larceny 5<sup>th</sup> Degree, 53a-167a- Interfering with an Officer, and 54-170- Fugitive from Justice. He was held on a \$10,000.00 bond.

McIntyre was charged with violation of Connecticut General Statutes 53a-48/53a-125a- Conspiracy to Commit Larceny 5<sup>th</sup> Degree and 54-170- Fugitive from Justice. He was held on a \$10,000.00 bond.
