REQUIREMENTS FOR EXCAVATION PERMITS

Originally Issued: March 19, 1992 Revised: February 3, 2005

The following is a list of items specified in the Town of Wallingford Excavation Ordinance, which must be furnished before any Excavation Permits can be issued. A copy of the Excavation Ordinance, which details requirements and obligations of the contractor, will be issued upon request.

1) Insurance and Bond

a) Insurance: Evidence of public liability insurance of not less than:

\$2,000,000 aggregate \$1,000,000 automobile \$1,000,000 per incident

b) <u>Bond</u>: Evidence of a performance bond in an amount of not less than \$5,000 or in greater amounts if required by the Department of Engineering, said bond shall be provided on the forms provided by the Department of Engineering.

2) Call Before You Dig

As required by the State of Connecticut Statutes, the Applicant must notify the Call Before Your Dig (CBYD) clearinghouse and furnish the Department of Engineering with a valid ticket number for each excavation prior to the issuance of any permits. Expired ticket numbers will not be accepted.

3) Backfill Material Certifications and Proposed Construction Procedures

The Department of Engineering will require detailed plans and specifications for the proposed excavation along with other engineering data prior to issuing any permits. Please refer to attached "NOTICE" and Trench and Pavement Repair drawing.

4) Fees

- a) \$5.00 for the first 200 square feet of excavated area or fraction thereof.
- b) \$5.00 for each additional 400 square feet of excavated area or fraction thereof.

NOTICE TO CONTRACTORS

EXCAVATIONS WITHIN THE PUBLIC RIGHT-OF-WAY

- 1) Application forms for all non-emergency work must be submitted a minimum of five (5) working days in advance of the scheduled start-date,
- 2) Incomplete Applications will not be processed and will be returned to the Applicant,
- 3) Bonds and Insurance certificates MUST be name of the Applicant or Contractor, whoever is performing the work and said certificates MUST be current or the Application will not be processed,
- 4) The required manpower / equipment list, material certifications and proposed sequence of construction MUST be completed and submitted with the Application,
- 5) The Applicant / Contractor shall designate the "official" project representative, who will be in charge of the on-site work. Contact name and a reachable telephone number MUST be provided,
- 6) At the time the Excavation Permit is issued, the Applicant MUST sign and date the form, acknowledging acceptance of any specific Conditions of Approval. A copy of the signed form will be kept by the Department of Engineering,
- 7) The Applicant / Contractor MUST notify the Department of Engineering (by phone or fax) a minimum of 24 hours in advance of the start of any excavation in the Public Right-of-Way,
- 8) The Excavation Permit, with all attachments and any specific Conditions of Approval MUST be on the job site with the designated project representative at all times when there is active work,
- 9) The Applicant / Contractor MUST notify the Wallingford Police Department Dispatch Center (203-294-2800) when the permitted work will alter or otherwise impact normal traffic operations (ie; alternating traffic flows thru the work zone, etc),
- 10) Road closures are NOT permitted, unless a separate "Road Closure Permit" has been jointly issued by the Wallingford Police Department and Department of Engineering, and
- 11) Any individual, firm, company or business entity determined to be in violation of these Conditions shall be subject to the enforcement provision of the Ordinance, as well as the immediate revocation of the subject permit, the suspension on the issuance of any new Excavation Permits, the cost of any repairs or remedial work and other such actions as may be determined by the Town to insure, protect and maintain the integrity of the Town's municipal Right-of-Way.





- 4. SUBBASE SHALL MEET REQUIREMENTS OF CDOT FORM 814A SECTION M.02.01 FOR GRADATION "B" MATERIAL.


DETAIL SHEET







6. SUBBASE MATERIAL SHALL CONFORM TO CDOT FORM 816 SECTION M.02.01 FOR GRADATION "B" MATERIAL.
