Dear Mr. Killen:

I am in receipt of a Report of Hearing Officer Commissioner Gloria Schaffer, Freedom of Information Commission dated, December 15, 1988, which address the problem of access to tapes of the Wallingford Town Council. As public records administrator, I find it pertinent to bring to your attention that recorded tapes are public records within the meaning of Section 1-18a (d) of the General Statutes, and, that said tapes must be stored in an accessible place such as the Town Clerk's office for access by the public.

To continue, recorded tapes shall not be removed from Town Hall at anytime. They shall be transcribed on premises by the recording secretary. I call your attention to Section 1-19 CGS, which reads in part "... each such agency shall keep and maintain <u>all</u> public records in its custody <u>at its regular office or</u> <u>place of business</u> in an accessible place and <u>if there is no such office or</u> <u>place of business</u>, the public records pertaining to such agency shall be kept in the office of Clerk. (emphasis added).

Prompt transcription of minutes shall be expected to conform with Section 1-21 of the Statutes.

In sum, I am directing you to conform with said statutes quoted above in accordance with Section 11-8 CGS. Finally, I ask that you acknowledge this letter by February 12, 1989 with a plan of action to clear up the problem of recorded tapes as public records.
