December 2, 2008

The following is a record of the minutes of the Regular Meeting of the Wallingford Town Council held Tuesday, December 2, 2008, Robert Earley Auditorium of the Wallingford Town Hall. The Meeting was Called to Order at 6:40 P.M. Responding present to the Roll Call given by Town Council Secretary Sandra Weekes were Councilors Mike Brodinsky, Nick Economopoulos, Jerry Farrell, Jr., John LeTourneau, Rosemary Rascati, Michael Spiteri and Vincent F. Testa, Jr. Mayor William W. Dickinson, Jr. and Corporation Counsel Adam Mantzaris were also present. Councilor Robert F. Parisi arrived at the meeting at 6:50 P.M. and Councilor Vincenzo M. DiNatale arrived at the meeting at 7:43 P.M.

Chairman Brodinsky began the meeting with a Moment of Silence and asked those present to remember Pasquale Mellilo, who passed away on November 19. He said that Pat was a frequent visitor to the Town Council meetings and that a frequent contributor to the Council's proceedings and that everyone will remember him fondly.

The Pledge of Allegiance and the Roll Call was taken.

5. PUBLIC QUESTION AND ANSWER PERIOD

Geno Zandri, 9 Balsam Ridge Circle, expressed his appreciation for having the pot holes on the John Street bridge filled. He asked that the parking lights that are out in the Town Hall parking lot be replaced.

Bob Gross, 114 Long Hill Road, asked if a 3rd attorney would be reviewing the Covanta and CRRA proposals. Chairman Brodinsky reminded Mr. Gross that the proposals were being reviewed by the five Town Attorneys from the 5-town partners that Wallingford currently has. Mr. Gross said that other towns would not be reviewing the Pilot Program and to recall where we were 20 years ago and where we will be in 20 years. Chairman Brodinsky said that the proposals have been reviewed and he does not foresee any problems with them. He added that this item would be on the agenda for the Dec. 16th Town Council meeting.

10. Discussion and Possible Action on Marketing 1300 Barnes Road – Chairman Mike Brodinsky

Chairman Brodinsky said that 1300 Barnes Road is town-owned property that was acquired in the 1940s via foreclosure, and it has been sitting in our ownership since that time and that it came to the Council's attention in 2007 when Habitat for Humanity expressed an interest in the lot. He said that he asked the Engineering Department for a map of the property, not an A-2 survey, but an unofficial map that is pretty accurate except for a possible encroachment by a neighbor on this town-owned property in the form of a driveway. He said that it would be difficult to sell with the encroachment, if there is one, until that is resolved. He said that he is suggesting to the Council if there is any interest in referring this to the Law Department to find out if there is an encroachment, and, if so, what it is and what action is necessary and appropriate to give some options to resolve the problem so that it can be sold without any complications. He said that Attorney Small is aware that this referral might be coming to the Law Department. He said that if we are not interested in selling the property then the Council would draw her into it.

Mr. Farrell asked how extensive would the action regarding the encroachment be. He said that you couldn't gain adverse possession against the sovereign, so seemingly it is a matter of telling the people to remove the encroachment, and that if that is not done then to take court action. He said that it wouldn't seem that complicated. Chairman Brodinsky said that there may be some amicable options. Chairman Brodinsky said that it is more serious than 10 or 15 feet.

Mr. Farrell said now that we have knowledge that there is an encroachment that the town should not allow the encroachment to continue no matter what the town ultimately does with the property. He said that he would be in favor or referring it to the Town Attorney to get some action on it.

Mr. Testa and. LeTourneau confirmed the location of the property in relation to Rt. I-91and on the map.

Chairman Brodinsky made a motion to refer the matter to the Law Department for resolution of the encroachment and to make recommendations on other reasonable and appropriate action that the Council may take up. Mr. Farrell seconded. All Councilors present (8) voted Aye. Mr. DiNatale was absent. The motion carried.

Mr. Testa announced that the Council must wait until 7:45 P.M. for the Public Hearing and the Council will at this time move onto the Executive Sessions.
