Bill Comerford of Broadview Drive asked if 3i had been removed from the agenda and why. Chairman Marrone stated that 3i was removed from the Human Resources Department. Mr., Comerford wanted to know if 3f was approved, which it was. He had asked Mayor Cervoni if the draft report was approved yet and if he had looked at it yet. Mayor Cervoni stated that he has begun reviewing the report. Mr. Comerford discussed why he wanted the basketball court item 3f pulled from the agenda for discussion. He stated that he had sent pictures to the council showing his concerns. He discussed the issue of the fence being at the out of bounds line at the park. He mentioned having pictures from 2022 where is fence line is three feet from the out of bounds line where now it is four inches. Mayor Cervoni said the foot print of the basketball court never changed. Mr. Comerford wanted to know who signed off on the fence being four inches from the out of bounds line. He talked about the water problems at the park and the five foot sidewalk that will be installed. Chairman Marrone intervened to ask if it is the project at the park that Mr. Comerford is unhappy with or just certain aspects of the project. Mr. Comerford stated that it is a poorly designed project. Benches will be added to the park near the basketball court and he asked if there will be a sidewalk to the bench to make sure that

it is ADA compliant.
