Attorney Farrell stated that to have Hidden Brook Lane excepted as a public road there must be some easements. One property owner is coming in to meet with Corporation Council Small. One property owner has executed the agreement. The Public Works Director and the Town Engineer will be attending the meeting with Corporation Counsel Small. He mentioned it took a couple of letters before people to start coming in. As far as the \$39,400 bond funds are concerned, they are for public improvements and sedimentation control, and the town is in possession of those funds.

Attorney Farrell stated that it is park of the town's parking lot on the north end of the parking lot. It is adjacent To where the Wallingford Post used to be going back. There are apartments in there. Part of the building is located on the town's property. It is going to be 5' x 79' and they need the easement to also. They hope to add more parking spaces to that. The Fire Department needs access through there. Corporation Council Small approached Appraiser Kathy Amadeo and asked for a full appraisal but because this is just an easement the price of \$2,500 would be fair. They are asking the town to approve this. The easement does not touch any of the trees there. There are trees adjacent to the property in the back ad no trees will be lost.

Mayor Cervoni stated that even though it is part of the town's parking lot, it is the unfinished portion that they use. The land that they are talking about granting to easement over is north of our guard rail. The requester has intentions to clean it up. He does have a modification of the use of the property that has been approved by the Planning & Zoning Commission and it is consistent with the downtown development that Planning & Zoning is working towards.

Vice Chair Tatta asked if the tenants would use the town parking lot or use their own parking.

Mayor Cervoni stated that the building has parking on the north side of the building. So, it does have its own parking.

Lawrence Coassin Jr of Meridan Road in Fairfield, CT stated that it is the parking lot for the building.

Vice Chair Tatta stated that she drove by the property to see about the trees and if they were still there. She asked how the building ended up on the town's property.

Attorney Farrell stated that he does not know the history of the building. He mentioned that the building has been there for a long time.

Vice Chair Tatta stated that she agrees with the proposed payment for this easement. She mentioned another easement that was approved with no money return except for \$10 from Choate for the air easement for the bridge. She mentioned that if the town asked Choate to pay money for the easement they would have gladly paid but now the town is asking for money for this easement.

Councilor Fishbein asked if the town received an appraisal for the air easement.

Attorney Farrell stated that he did not know of any appraisal for the air easement.

Mayor Cervoni stated that they took a similar approach by calling an appraiser to ask if there was value to conduct an appraisal. The appraiser believed it is very hard to appraise air.

There was a voice vote taken and all members present at the meeting were in favor. Motion passes.

Attorney Farrell stated that this is a Law Department request and that they have already received \$300,000 in settlements through these various opioid settlements and the amount they will get depends on how many towns choose to take part in this. The use of it is limited to how the Health Department. It has to be used in helping drug rehabilitation.

Chairman Marrone asked if the town can pursue legal action on their own.

Attorney Farrell stated that his understanding is, if the town opts into this, they give up the right to a lawsuit in the future. For the town to do their own lawsuit it would be expensive, he stated.

Mayor Cervoni stated that this is part of the bankruptcy state and because they are in bankruptcy, the town's only ability to participate in this resolution is to participate in the bankruptcy process. Once they revoke the bankruptcy process, you do not have the ability to sue them outside of the bankruptcy court. He mentioned that this is consistent with how you pursue claims with them.

There was a voice vote taken and all members present at the meeting were in favor. Motion passes.
