8. Consider and approve Extension of the License Agreement between the Town of Wallingford and Fred M. Valenti regarding encroachment of building located at 800 South Colony Road for ten years to 2033 – Law Dept.

In Attendance: Mr. Fred Valenti

Attorney Farrell explained that an encroachment exists of approximately 155 square feet of building and 2500 sq. feet of fencing. He went on to say for business reasons, Mr. Valenti is

asking for a ten year extension of the License Agreement. Attorney Farrell indicated that we receive \$2,000 a year for this encroachment.

Councilor Fishbein questioned with regard to mortgaging the property, if usage would not be legal absent using the town land. He then asked if we are insured and why we are back so soon discussing this issue. Mr. Valenti explained that there is a franchise agreement and should they build a new facility, the work would have to be complete within the ten year timeframe. Mr. Valenti also stated that the encroachment is insured the same as the owned portion of the site.

Attorney Farrell stated that we have the right to remove with one year notice and we have insurance.

Councilor Fishbein stated he is in favor of this concept but is concerned about being sued.

Chairman Cevoni asked Mr. Valenti to keep notifying the Mayor's office of insurance.

Councilor Fishbein asked if the Town can be named on the insurance. Mr. Valenti does not think there will be a problem with that.

Attorney Farrell suggested passing the Motion contingent upon adding the Town on the property Insurance.

9. Discussion regarding moving Voting District 9 from Rock Hill School to an alternate location – Councilor Fishbein

In Attendance: Chet Miller, Registrar of Voters

Councilor Fishbein stated that the parking on election day at Rock Hill School was the worst that he has experienced with many parking spaces occupied by teachers and nursing students. Many voters approached him and asked him to do something about the parking. He stated that Chief Heidgerd is opposed to moving the polling place to the firehouse. He went on to say that Dr. Menzo indicated the school will not be used for professional development purposes on election day in the future.

Councilor Shortell asked how long Rock Hill School has been a polling place. Mr. Miller responded 20 years.

Mr. Miller stated he has not heard many complaints about parking, but has heard complaints about distance to travel to vote. He also stated that this may be changed in 2022 after the results of the 2020 Census are considered.
