11. Discussion and possible action regarding resuming Wallingford Energy Conservation Commission and nomination of the following to the Commission: Adelheid Koepfer, Mary Mushinsky, Alida Cella, Mark Deptula, Ben Martin, Tracy Carim, Jim Quarello, Pat Reynolds – Councilor Morgenstein

In Attendance: Ben Martin, 329 Ward Street Mark Deptula, Supervisor of Building and Grounds, Board of Education

Councilor Morgenstein stated she is happy to see this coming forward.

Mr. Martin explained in 2008 we initially found low cost ways to find energy savings. He noted we worked with Stop & Shop to install electric chargers for cars and with the schools for savings.

Chairman Cervoni asked when was the last time this was active? Mr. Martin replied 2014.

Mayor Dickinson stated that Eversource has no jurisdiction in town and went on to explain we have an energy department ourselves so we handle that.

Councilor Zandri stated he's always interested in conservation but he asked does it do anything to destabilize costs of utilities. Mr. Martin replied that we are not at a point where that would make a difference in the state.

Councilor Shortell wants to know if we are being asked to reappoint this dormant committee tonight. He explained whether he is for this or not, he is not going to support this at this time. He believes they should all have a say, each Councilor or the Town Committees, in who is appointed to the Commission.

Mr. Martin stated this is a nonpartisan Commission.

Councilor Shortell feels we should take a step back. He then asked if we could accomplish this through the Public Utilities Commission. Mr. Martin stated he thinks they are very busy.

Mayor Dickinson explained \$1.5 million is collected each year through the utilities and performs energy conservation through our utilities division. He went on to state we are obligated to spend this in conservation.

Councilor Marrone stated he is not sure what we can do that you wouldn't do before.

Mr. Martin indicated a reason for the town departments to meet with us is it provides us a foot in the door. He remarked we are talking about improvements.

Councilor Marrone asked what type of projects would you do? Mr. Deptula stated at the school, we changed lighting and we went to efficient boilers.

Councilor Marrone indicated in theory he is okay but he needs to know more about the members.

Chairman Cervoni stated to Mr. Martin you mentioned that the conservation load management was only for commercial properties but I had an audit done on my home here.

Councilor Testa stated it's easy to ask why we need this group but there is a certain degree of credibility of being sanctioned by the town if we approve it. He thinks this group would be looking at many areas and making presentations to many departments.

Councilor Laffin stated he is hearing this as a re-boot and asked Mr. Martin what his relationship was in the past with PUC. Mr. Martin replied they provided us with data on the biggest users, no official relationship. Councilor Laffin asked what if they said no and Mr. Martin stated we really are only advisory. Councilor Laffin then asked Mr. Martin if he was given a charge. Mr. Martin stated he did not remember it was 12 years ago. Councilor Laffin indicated if we are going forward with this, he wants a charge and a say in who is on it.

Councilor Tatta asked Mr. Deptula if the schools are currently going through an audit through the PUC. Mr. Deptula replied no, not through the PUC, through the schools and stated there are lots of opportunities for new projects. He went on to say we upgraded to new lights, LED's, a substantial savings.

Councilor Tatta stated she is reluctant to go forward tonight and indicated minority representation. She asked if everyone lives in town and asked when it was created. Mr. Martin replied 2008.

Councilor Morgenstein indicated she sees an opportunity tonight to reform an Energy Conservation Commission. She would like to see this Council tonight reform this Committee.

Councilor Marrone went back to Councilor Testa's question and remarked why not form this group. He stated there becomes an expense to that and went on to say look at the Coalition, we had to rent them space downtown. He asked if this is just a regroup then why do we have to do anything why can't they just start up again.

Councilor Zandri stated this Committee existed for six years before and he feels this is good for us to consider.

Councilor Laffin feels we should take a deep breath and make the right decision. He suggested maybe waiting two weeks would be a good decision to get questions answered.

Councilor Shortell mentioned they interviewed seven people for Public Celebrations two years ago and noted similar examples such as the Coalition and Wallingford Center Inc. without the Council forming a Commission. He feels we should take our time tonight and stated he will be voting no.

PUBLIC COMMENT

Bob Gross, Long Hill Road, wants to know if they have to use the money from the Electric Division for the audit. Mayor Dickinson answered typically yes and indicated it must show cost reduction. He stated that the program works well.

Larry Morgenstein, South Main Street, said he is at a loss at what happens at these meetings. He went on to say here is a gift of a Committee that can save the town money and we spend time to see how we cannot do this.

State Representative Mary Mushinsky, a previous Board Member, spoke about an award we got from the Commission – second in the state. She feels we should hold off on the vote tonight and come up with a bipartisan Commission.
