Attached for your review is a request for a budget transfer for fiscal year 2019-2020 in the amount of \$8,350 to Account 372 - Distribution Plant – Leased Property. This account reflects the material costs for new private light installations on customer premises and the replacement our customer's existing high pressure sodium (HPS) lights with LED light fixtures. A review of the account at year end has found that a previous request for a budget transfer submitted July 15, 2020, did not include the correct amount for inventory issues used in the LED replacements of private lights. As a result, an additional \$8,350 will be needed to close the fiscal year.

Over the past fiscal year various employees, who have experienced a work related injury, have been examined and approved for a permanent workers compensation disability award pursuant to their treating physician. These types of awards are funded by the Division's Workers Compensation Reserve. As a result, each year the Division allocates funds to replenish this reserve.

During fiscal year 2019-20 the amount required to restore the reserve balance is \$52,200. Accordingly, a transfer increasing account #4310925 (Injuries and Damages) is requested. The value of this time must then be recognized as a liability of the Division. Although the value of the accrued liability may increase or decrease it most commonly increases due to increases in wage rates and accrued sick time from year to year.

In the Water Division the increased value of the sick and vacation accrual for fiscal 2019-20 will require an increase to account #43100926 (Employee Pension/Benefits) in the amount of \$23,200.00. Funds for this purpose will be made available through a decrease to Account #43100677 (Maintenance of Hydrants) where funds were unexpended due to an unresponsive hydrant painting contractor.

Funds for this purpose will be made available through a decrease to Account #46100643 (Miscellaneous Expenses) where funds were unexpended due to lower than budgeted electrical expenses.

As you are aware, during Fiscal Year 2019-2020, the Town of Wallingford Sewer Division has received substantial payments from the State of Connecticut Department of Energy and Environmental Protection's Clean Water Fund for the construction and construction engineering of tertiary phosphorous related capital improvements to the wastewater treatment plant. Each payment from the Clean Water Fund to the Sewer Division is allocated as a grant or loan component. The first payment to the Town was received on February 5, 2020 and the loan component for all payments received through June 30, 2020 totals \$8,013,003.67.

Although the actual payments on the loan balance will not begin until the Town enters into a Permanent Funding Obligation with the State of Connecticut, Generally Accepted Accounting Principles require that interest accruing on this loan balance be recognized as an expense in the period in which it occurs. To date, the accrued interest totals approximately \$49,000. However, when the Fiscal Year 2019-2020 budget was prepared in February 2019, the Town had not yet received approval of any State funding or awarded the construction contract thus, this expense was not included in the FY19-20 budget. As a result, a budget transfer in the amount of \$49,000 will be necessary to fund this expense in the Division's Fiscal Year 2019-2020 budget.

Therefore, a budget transfer increasing account #46100427 (Interest On Long Term Debt) in the amount of \$49,000 along with a corresponding decrease to account #46100673 (Maintenance Of Collection System) is requested. Funds are available from this account due to lower than budgeted manhole repairs.

Upon your approval please forward this request to the Public Utilities Commission for their consideration.

AMENDMENTS TO CHAPTER 43, "PURCHASING" OF THE CODE OF THE TOWN OF WALLINGFORD

BE IT ENACTED BY THE TOWN COUNCIL IN SESSION:

That Chapter 43 of the Code of the Town of Wallingford, "Purchasing" is hereby amended as follows:

1. That §43-11.A of the Code of the Town of Wallingford, "Formal contract procedure", of Chapter 43, "Purchasing" is hereby amended as follows:

§43.11. Formal contract procedure.

A. Purchases shall be made under such rules and regulations established by this chapter by the Council, provided that, if any purchase or contract for purchasing, including a continuing order or contract for the purchase of the same commodity or service over a period of time, involves the expenditure of \$16,000.00 or more, the Purchasing Agent, unless it shall be determined by the Town Council to be against the best interests of the Town, shall invite sealed bids or proposals, giving sufficient publication to the trade and/or profession and 10 days' public notice thereof by publication at least once in a newspaper having a circulation in the Town, and shall let the purchase or contract to the lowest responsible bidder thereon or may reject any or all such bids or proposals. All such sealed bids or proposals shall be opened publicly.

2. That §43-12.A and §43-12.B of the Code of the Town of Wallingford, "Open market procedure", of Chapter 43, "Purchasing" is hereby amended as follows:

§43-12. Open market procedure.

A. All purchases and supplies and contractual services of less than the estimated value of \$16,000 shall be made in the open market, without newspaper advertisement and without observing the procedure prescribed by § 43-11 for the award of formal contracts.

B. Minimum number of quotes. All open-market purchases over \$750.00 shall, wherever possible, be based on at least three competitive quotes and shall be awarded to the lowest responsive and responsible quoter. Whenever possible, reasonable efforts shall be made to obtain such quotes from vendors located in Wallingford.

3. That §43-15.A and §43-15.B of the Code of the Town of Wallingford, "Emergency purchases", of Chapter 43, "Purchasing" is hereby amended as follows:

§43-15. Emergency purchases.

A. In the event of an emergency requiring the expenditure in amounts of less than \$16,000, and the funds are available for expenditure, the Purchasing Agent may purchase through the open market procedure the supplies or services needed, or authorize the head of any agency or department to purchase directly the supplies or services which are needed. The Purchasing Agent shall use his/her best judgment to most effectively acquire the supplies and/or services.
