Wallingford Historic Properties Commission Annual Meeting

May 13, 2021 Minutes

- 1. Call to Order: The meeting was called to order at 6:44 p.m. by chair Kimberly Lode-Dellaselva.
- 2. Roll Call: Chair Lode-Dellaselva conducted a roll call.
- 3. Approval of Minutes: Commissioner Christie Collett motioned to accept the minutes of November 19, 2020. Commissioner Knapp seconded the motion. The motion to accept the minutes carried unanimously by the remainder of the Commissioners.
- 4. Overview and Status of Properties: The properties under the jurisdiction of this committee are the following: Blakeslee property, Royce House, Johnson Mansion. There were no new updates to discuss.

- 6. Review and Discuss Annual Report Draft: Commissioner Lode-Dellaselva had e-mailed a draft of the 2020-2021 Wallingford Historic Properties Commission annual report to the Commission prior to the meeting. Chair Lode-Dellaselva will recommend reappointment to the Town Council. They will follow up with a letter to the Chair of the Town Council expressing interest in reappointment.
- 8. Selection of Officers: Commissioner Sibley made a motion to continue the existing slate of officers. Commissioner Knapp seconded. No objections were made. The motion carried unanimously.
- 9. Old Business: None.

10. New Business: Commissioner Knapp raised a concern regarding the two unfilled Alternative seats. Chair Lode-Dellaselva will make the Town Council aware and ask that they appoint two Commissioners. Discussion ensued regarding advertising the openings either in the newspaper or on the Wallingford Community Forum on Facebook. Chair Lode-Dellaselva will look for examples of past advertisements in the archival files of the Commission and share with Town Council.
