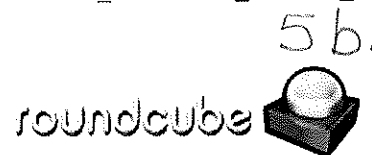

Vinny and Chris:

As co-chairs of the Ordinance Committee, I submit the following for discussion purposes at our meeting on August 3, 2021:

That Section 46 of the Town of Wallingford's Ordinances entitled, "Reserve Accounts" be amended to include a subdivision called, "Town of Wallingford Dog Pound Expendable Trust Fund" and that within said subsection, after establishing the intent and purpose of this particular fund, that there be a procedure something along the lines of:

"The Animal Control Officer is authorized to make requests for appropriations from the fund. Those requests shall be in writing (unless an emergency makes such a writing unreasonable), and submitted to the Mayor, with a copy of the written request being forwarded to the Town Council within 48 hours of the request. The Mayor's response to the request shall also be in writing, and shall be received by the Animal Control Officer within 7 days of the request, with a copy of the response being forwarded to the Town Council within 48 hours thereafter. In the case of an emergency, not including writings, the Town Council shall be informed of the request and response in a reasonable manner within a reasonable time after the request, as well as after the response."

I thank you in advance for your kind attention to this matter, and look forward to our upcoming discussions.
