## Wallingford Historic Properties Commission Annual Meeting

## March 15, 2022 Minutes

- 1. Call to Order: The meeting was called to order at 6:11 p.m. by chair Kimberly Lode-Dellaselva.
- 2. Roll Call: Chair Lode-Dellaselva conducted a roll call.
- 3. Approval of Minutes: Chair Lode-Dellaselva noted the date on the minutes was incorrect. The year was mistakenly typed 2020 instead of 2021. Commissioner Tara Knapp motioned to accept the minutes of May 13, 2021 with the amended date. Commissioner Barbara Sibley seconded the motion. The motion to accept the minutes carried unanimously by the remainder of the Commissioners.
- 4. Overview and Status of Properties: The properties under the jurisdiction of this committee are the following: Blakeslee property, Royce House, Johnson Mansion. There were no new updates to discuss.

- 6. Review and Discuss Annual Report Draft: Commissioner Lode-Dellaselva had e-mailed a draft of the 2021-2022 Wallingford Historic Properties Commission annual report to the Commission prior to the meeting. - 8. Selection of Officers: Commissioner Sibley made a motion to continue the existing slate of officers. Commissioner Prentice seconded. No objections were made. The motion carried unanimously.

She confirmed that was true and made the caller aware of the process for filling those seats which is through the Town Council. There was no other new business.
