### ANIMAL CONTROL

In Attendance: Mitch Gibbs, Animal Control Officer

Councilor Zandri inquired about differential and increase and wants to confirm this is the offset for additional full-time positions. Mr. Gibbs stated yes and also increase in pay

Councilor Zandri asked if the hot water is working and Mr. Gibbs answered yes.

Councilor Zandri inquired about the trust fund balance. The Mayor said it's in the range of \$600,000-\$700,000. Councilor Zandri said he will follow up on that. Councilor Zandri asked Mr. Gibbs if he felt he got what he needed and Mr. Gibbs said I believe did.

The Mayor stated the position added is full-time and noted its difficult getting part-time.

#### PUBLIC WORKS

In Attendance: Rob Baltramaitis, Director, Public Works Stephen Palermo, Superintendent, Public Works Mary Kenney, Executive Secretary, Public Works Councilor Tatta mentioned an email from a resident stating the grass is high at Dutton Park.

Mr. Baltramaitis said there is not a lack of funding just fell behind because of the rain.

Councilor Carmody stated he did not see a line for salt budget. Mr. Baltramaitis referred to OP/Maintenance – Other supplies included \$400,000 for salt based on five years.

# <u>FIRE</u>

In Attendance: Samuel Wilson, Fire Chief

Mr. Wilson read opening statement.

Councilor Marrone asked if all firemen are paramedics. Chief stated typically we try to hire firefighter/paramedics. Chief went on to state they are budgeted for two additional EMTs.

Councilor Marrone and Chief discuss ambulance, EMT's and paramedics. Councilor Marrone would like a third party study and Chief said he would not object to that.

Tim Wall encourages Town Council to support fire budget.

Bob Gross, Long Hill Road, stated ARPA funds could be used to compensate Fire Department for work done during pandemic.
