Fran LaFrance-Proscino, Jackson Avenue, wanted to let Administration know that business owners are waiting to speak about ARPA funds and stated business owners are really struggling. She feels 60 employees is too high a threshold for the application and believes 25 is a better number.

Amy Hunter, Amy's Cakes, 236 North Colony Road, asked Town Council to think about small businesses. She mentioned that rents are going up and it's hard to keep up. She stated it's disappointing to hear so much about the pool. She remarked needs versus wants and would like the Town Council to think of businesses first.

Robin Jackson, Nutmeg Kettle Corn, 2 Chapel Street, stated mom and pop businesses are much smaller than 60 employees. She went on to state they do need funds, they are behind in rent, and they can't pay salaries. She appreciates the Administration and Town Council and remarked the town pool does not put food on the table.

Herb Jackson stated money is being given by the government to help businesses service the town 12 months a year where the pool helps the community 2 months a year. He would like the business owners to understand the parameters by Council members making a decision and creating a process. He then asked if small business owners are part of the subcommittee to provide input. He feels Council should clarify information from business owners on needs before they make revisions to the process.

Mike Silengo and Greg Barbiero, The Cutting Edge Training Center, stated they are just struggling and have not seen a rebound in business. They have a small indoor facility and parents are nervous to bring kids. They need movement very soon in order to keep their doors opens.

Joe Mirra, EDC, is a fan of the pool but is disappointed that it got brought up tonight as it is not on the agenda. He noted small business has been on the agenda for six months with no resolution. He said this is not the Wallingford he knows.

Mr. Gross asked Mr. Reagan if other towns had a capped amount for ARPA funds. Mr. Reagan responded it varies \$25,000 to open-ended. Mr. Gross asked if the town has reached out to all small businesses during the process. Mr. Mirra responded that EDC with one and a half persons has done a lot of work to notify businesses through the website, the chamber and phone calls. Mr. Mirra went on to state EDC is a proactive team.

Mr. Gross asked if churches are included as non-profits. Attorney Small replied 501C3 and veterans but she will do additional research.
