Dear Co-Chairs Harp and Dyson:

I am writing to you as Chief of the North Farms Volunteer Fire Department in Wallingford, CT. I have a concern with the governor's proposed Budget for the FY2003-FY2005 Biennium. In the Governor's Budget FY2003-FY2005 <u>all funding for the Limited Access Highway</u> <u>Reimbursement Program administered by the Commission on Fire Prevention and Control as</u> <u>authorized by the Connecticut General Statutes Sec. 13a-248 has been eliminated.</u>

The Town of Wallingford's Fire Department is a combination fire department, with paid and volunteer fire fighters. We respond to numerous incidents on Limited Access Highways in our town. The program called for us to receive a reimbursement of \$75.00 each time we responded to a call on the Limited Access Highways in our town. In 1971 this was raised to \$100.00 with no increase since this time. I am asking that this program not be eliminated from the budget.

I believe that fire departments in the State of Connecticut perform a vital public safety service to the state by responding to calls on the Limited Access Highways. It is important that we are able to put in for the reimbursement. The money helps to off set costs of equipment for our firehouses, as well as operating expenses. I have attached a copy of the Budget for the Commission on Fire Prevention and Control, which shows the elimination of the program.
