BE IT RESOLVED THAT:

In connection with contracts between Wallingford and ORRA and involving the four other towns in the Wallingford Resource Recovery Project, concerning

the landfill lease,

the choice of operator for the incinerator,

the tipping fee at the incinerator and landfill,

the lawsuit against Wallingford's Planning and Zoning Commission regarding the Meriden landfill, the host town benefits, and

any other action which may bind the Town of Wallingford in connection with this Project,

a negotiating team is established which includes the Mayor and any Council members who indicate a willingness to participate.

The negotiating team shall report to the full Council and the Council shall be the final authority in deciding what action the Town shall take in connection with any of the above, including authorization at an appropriate time, after review of any agreements by the Council to authorize the Mayor to sign on behalf of the Town of Wallingford specific agreements which have prior Council approval.
