Attached is a Sewer Division budget transfer request to increase our Maintenance of Pumping Equipment account (#633-000) by \$6,000.00 with a corresponding decrease to our Power Purchased and Natural Gas account (#643-000).

The additional funds are needed due to unanticipated major repairs to the Durham Road Pumping Station. It was necessary to replace the motor control starters and related equipment.

The funds are available in the Power Purchased account due to the components of the new sewage treatment plant which have not come on line as was expected.

Attached is a Sewer Division budget transfer request to increase account 624-000 - Pumping Labor & Expenses and decrease account 642-000 - Operation Labor by \$24,000.00 respectively.

The funds are needed to cover additional overtime incurred to maintain continuous operation of the diesel driven sewage pump that is being utilized at the low level pumping station to assure adequate pumping capacity until such time as pumps purchased by public bid are received and installed. This condition is created due to the delay of the new low level pumping station construction.

The funds are available in the treatment facility labor account (642-000) due to unfilled positions.
