The Transfer is from Acct. #001-2032-100-1200, Fire Chief's Wages to Acct. #001-2037-500-5000, Maintenance of Vehicles in the amount of \$2,500.00.

Motion was made by Mr. Bradley, seconded by Mr. Holmes.

Mr. Zandri stated that he would be voting against this transfer due to the fact that he objects to where the dollars are coming from which is a wage account.

Killen asked if it was apparent that the brakes were going to needing replacement in the future. In other words, was the truck checked out in the recent past and was the department warned that the brakes would need replacement in the near future?

Chief Lefebvre responded that the vehicles are checked out periodically by a mechanic and the brake wear is normal. The hydrovac deterioration was not anticipated.

Mr. Killen asked if this is one in a series of events that will occur over the next year, will the Town be pouring dollars such as these into the used truck again?

The Chief did not anticipate any major work being done within the next year on the vehicle since the motor was worked on recently.

Mr. Solinsky asked if regular check-ups are performed?

Chief Lefebvre responded, yes.

Mr. Solinsky asked if the condition appeared suddenly or gradually?

An unidentified source responded, it was gradually.
