Councilor Cervoni stated that he had removed the item from the Consent Agenda when he learned that members of the family of Dr. Haakonsen would be in attendance tonight. Chairman Parisi asked if Dr. Gebhardt was in attendance. Mayor Dickinson said that he was assuming that they didn't plan on attending because this item was scheduled on the Consent Agenda. He continued saying that the Conservation Commission has heartily endorsed naming the fishway after Harry Haakonsen and we are blessed by having family members here tonight. Dr. Haakonsen's reputation and efforts with regard to the environment are known in the community. He was very active, a very respected member of the community, and it is recognizing that legacy and the kind of person he was that brings us to the point of naming this new fishway which provides a whole new world for our finned friends to be able to head upstream and live like they did many, many years ago.

Jeffrey Borne, Chairman, Conservation Commission, said that the Conservation Commission heartily supports naming the fishway in honor of Harry Haakonsen. Harry is a favorite son of Wallingford; he was a champion of open space and the town's natural resources; he appreciated the quality of life aspects to which those resources contributed, and for those reasons the Commission urges the Council to approve to name the fishway in honor of Harry Haakonsen. Mayor Dickinson added that the naming of it in his behalf will have his name be remembered and associated with such wonderful thoughts and actions on behalf of the environment.

Erik Haakonsen thanked everyone for this consideration on behalf of his sisters, his mother and himself, saying that they all are very touched by this thought. He said that he grew up at the fishway with Steve Gebhardt on Long Island Sound; he said that the Haakonsen family went to Norway for a year to learn more about Atlantic salmon and fishways. He remarked that family feels that this is such a fitting tribute.

There was long discussion with regard to tree cutting; identifying street trees as opposed to privately owned trees; and locations in town parks of certain trees being cut. They talked about stump grinding; determining which trees need to be cut/trimmed; professional tree companies and working around electrical wires.

Mr. McCully stated he is the tree warden; the transfer is within the department and will last in this budget category until the end of June. He added that the two-storm clean-up is still going on. He reported that FEMA funds for the town are being requested to offset what is being spent in this clean-up.
