6. Discussion and Possible Action regarding the sale of town owned property at 1222 Old Colony Road in the Amount of \$8,000 – Mayor

Mr. Jerry Pytel, owner of J & D Auto Sales LLC on property adjacent to the subject site in the Wallingford section known as Tracy, appeared before the Council accompanied by another gentleman. Even though Mr. Pytel has only requested to purchase from the town the parcel closest to his business totaling 6,618 s.f. for \$8,000, it was felt that both parcels should be sold for \$8,000. The second parcel calculates at 8,515 s.f. for a total of 15,133 s.f. It was noted in the discussion that the entire 15,133 s,f. has been appraised at \$8,000 and that the assessed value is \$5,600. There were comments of concern from some Councilors on procedure and consistency for this type of transaction.
