B) Cafeteria

In attendance: Sharlene Wong, Food Services Director Dr. Salvatore Menzo, Superintendent, Wallingford Public Schools

Sharlene Wong, Food Services Director, gave a report of the status of her department, stating that with increasing mandates from the State of Connecticut and the Federal Government and rising prices that she will be asking for subsidy from the town in future budgets. The Council discussed with Ms. Wong- a la carte; lunch prices; personnel costs; fund balance; aging equipment; hot lunches; free and reduced lunches and reimbursement; catering; banquets; Highland School garden; Wallingford model for the state and in a recent regional meeting, Wallingford was the only town not receiving a subsidy;

A) Board of Education

In attendance: Dr. Salvatore Menzo, Superintendent of Schools Roxanne McKay – Chairwoman, Board of Education Linda Winters, Business Manager Michael Brooder, Chairman, Operations Committee Many other board members and teachers present

Dr. Menzo gave a PowerPoint presentation on the Board of Education budget illustrating the history of funding, enhancements, educational improvements and the future which outlined unfunded mandates from the state and nationally. He spoke about certified staff reallocation and collaborative opportunities; no pre-purchasing; revenue areas; decreased enrollment; presentation and acceptance of new lacross program; crossing guard bids; out of district students; registration fees; instructional supplies; green chemicals; tuition rates - per pupil rate set by state; technology; develop revenue; special needs program; capital improvements; accomplishments –boilers, asbastos, safety units, driveways, bleachers, exhause fan; stats of students who participate in sports, boys and girls; Sheehan Pool, Parks and Recreation and the town; magnet schools and Open Choice-Wallingford participation.
