FY 2012 – 2013 BUDGET WORKSHOP

RECORD OF VOTES & MINUTES

The meeting was called to order at 6:03 P.M. in the Town Council Chambers of the Wallingford Town Hall. A Moment of Silence was observed, and the Pledge of Allegiance was said. Councilors in attendance were as follows: Vincent Cervoni, Craig C. Fishbein, Thomas Laffin, John LeTourneau, Chairman Robert F. Parisi, Rosemary Rascati, John J. Sullivan and Jason Zandri. Councilor Nick Economopoulos was absent from the meeting. Mayor William W. Dickinson, Jr. and Comptroller James Bowes were also in attendance at the meeting.

3. <u>BUDGET WORKSHOP</u>

Public Utilities Commission

In attendance: George Adair, Director, Public Utilities Robert Beaumont, Chairman, Public Utilities Commission David Gessert, Vice-Chairman, Public Utilities Commission Richard Nunn, Public Utilities Commissioner

Mr. Adair stated that the budget is basically the same; there are no new programs or additional staff but due to power supply contracts so funds have been added to the overtime line. The Council asked about commission expenses; mileage; and that each commissioner is paid approximately \$6,000 per year.

Water Division

In attendance: Roger Dann, General Manager George Adair, Director, Public Utilities William Phelan, Business Manager Robert Beaumont, Chairman, Public Utilities Commission David Gessert, Vice-Chairman, Public Utilities Commission Richard Nunn, Public Utilities Commissioner

Mr. Dann explained that in the upcoming year there are a number a projects (Line 923), a significant one is an update of the order supply plan; secondly there are repairs to hypochlorite storage area and repair of the water treatment plant where seepage has been detected.

Council inquired about large 2012-2013 budget increases from prior years; rent funds from leased areas for cellular usage; contributions-in Aid; responsibilities in restoration of roadways; Transmission and Distribution Mains; transportation equipment; maintenance of Wells & Springs; meter reading; meter reading changes; new meters; number of meter readers across all utilities; rates; and hydrant replacement.

Sewer Division

In attendance: Roger Dann, General Manager George Adair, Director, Public Utilities William Phelan, Business Manager Robert Beaumont, Chairman, Public Utilities Commission David Gessert, Vice-Chairman, Public Utilities Commission Richard Nunn, Public Utilities Commissioner

The Council inquired about Regulatory Commission Expenses; purchase of credits for removal of nitrogen from inflow and infiltration into the system; upcoming phosphorus regulations; rate increases; Loss and Depreciation; and grid washer and source of funds.

Electric Division

The Council asked about street and highway lighting; LED lighting; reporting of street lamp outages; poles and pole numbering; maintenance of poles; replacement of poles; upgrade of lights near the center of town; street light rates; division resident assistance; expansion of division boundaries near town center for business customer advantages; John Street security and roof replacement; downtown incentives; net mtering program; Line 391 office furniture line will include \$50,000-meter reading system and \$120,000 for installation outage management system.
