The Regular Meeting of the Wallingford Town Council was called to order at 6:31P.M. The Opening Prayer was offered by Deacon Eugene C. Riotte, Most Holy Trinity Church of Wallingford. 5. PUBLIC QUESTION & ANSWER PERIOD

Jennifer Johnson Short, 21 Pleasant Street, read a statement (Appendix II) with regard to addressing "the circumstances of her daughter's passing and of the critical role this community played in her short life." In speaking about the number of deaths of young people in a relatively short time due to drugs/alcohol, she asked for a call to action stating that the "train is broken." This problem needs to be looked at from all levels.

Craig Turner, Director, Youth and Social Services, said this is a compelling issue and it is hoped that to shift the tide, it is hoped that the addition of family members who have personally experienced these issues to be given an opportunity to voice their experiences within the context of looking to solve this with new strategies. He said that this comes at a time when the education department and some of the strategies they are looking at to enhance their programs and student success by incorporating the entire community.

Dr. Salvatore Menzo, Superintendent of Schools, presented a town-wide initiative, spurred on by the Innovation Team and the Wallingford Public Schools, to do a community read of the book <u>Mindset</u> by Carol Dweck, which looks at 'growth mindset' as opposed to 'fixed mindset'. He said that the author would skype from California into book discussions in Wallingford called 'March Madness for Mindset'. At a concluding meeting on March 20, Dr. Menzo said Al Terzi would facilitate a community conversation about investigating and developing core values. He said they have also embarked on an initiative called the "Wallingford 100," which is about "100% community plus 100% engagement equals 100% graduation rate." He stated that the focus isn't solely on getting students through high school, but getting them through high school with productive end-points, academically, socially, emotionally and to be true citizens in which they can themselves be proud. He gave the Town Council copies of the book.

Rich Figlewski, owner of 'Dry Dock' spoke about addiction in our community and the initiative look at core values; He said we need to love and care for each other.

Mary Ann Gracie, former, Wallingford educator, stated that this is a problem of the community. It does not belong to just the parents, or to the schools or to the police department. She said we all need to work together and not against each other.

(The purpose of the amendment is to increase the appropriation and bond authorization by \$4,000,000 from \$9,352,000 to \$13,352,000 and to ratify, confirm and adopt all prior authorizations and ordinances in connection therewith.)

Chairman Parisi convened the Public Hearing at 7:08 P.M. stating that the \$4,000,000 increase to the \$9,352,000 2011 School Roof Program appropriation and bond authorization is the subject of this Public Hearing. The Ordinance is available to the Public and may be obtained at this meeting from the Town Clerk.

Geno Zandri, 9 Balsam Ridge Circle, asked for a summary of what has been accomplished so far, and what the additional dollars would produce going forward.

Mr. Brodinsky introduced the panel (*as above*). The roof work began in 2012. All roofs that were worked on are finished, and most of the paper work has been completed with warranties in hand. He said that the 2012 project went well and smoothly and commented that they are happy with how things went. He noted that the community has been well served through the Council's decisions. He continued that they are now looking toward 2013 and six more school roof projects. This hearing is for getting additional sources of funds for 1) to satisfy the State of Connecticut in that we have locally committed to do these projects in 2013 but also 2) they need money in hand, so when bids are returned, provided the bids are approved, that there are funds to pay the roofers at least part-way though the projects.

The 2013 Construction Documents for the roofs for Cook Hill, Pond Hill, Moses Y. Beach, Parker Farms, Highland School and Rock Hill School are a work in progress. They anticipate receiving the final form of the documents in January. The local level review of those plans for code compliance will be done in February. In March, possibly March 6, the State of Connecticut will review the documentation and procedures, and everything that has been done to date. Bidding is next, probably in April 2013, and then construction can begin on July 1. He reviewed the plans that include hot-tarring to be completed by July 16 and all the rest by August 26.

He stated that the funds expended in 2012 are about \$9.8 million. He said the bonding authority is for \$9,352,000. Going into 2013 they need more bonding authority and the \$4 million on the agenda gets them to where they want to be going into 2013.

COUNCILOR CERVONI READ THE TITLE OF THE ORDINANCE AS FOLLOWS:

AN ORDINANCE APPROPRIATION \$13,352,000 FOR THE TOWN OF WALLINGFORD 2011 SCHOOL ROOF PROGRAM AND AUTHORIZING THE ISSUE OF \$13,352,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING TH ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE.

Geno Zandri, 9 Balsam Ridge Circle, asked if all the roofs that were worked on this year are complete. Mr. Brodinsky said yes, all are totally complete and that the plan is that all of the upcoming roofs would also be complete. When all that is complete then there is nothing left to do in this project.

James Bowes, Comptroller, added that this money is enough to get the project up to the bidding process, and then the roofing committee would come back to get the authorization increased.

With no one else coming forward, Chairman Parisi closed the Public Hearing.

Councilor Fishbein stated that the language of the ordinance does not mention the increase. He questioned that this seems like a new \$13,352,000, referring to the language of the proposed ordinance. He said he understands the intent but that is not expressed in the bold language.

Councilor Cervoni responded that it is to increase the overall authorization to include the \$4 million. Mr. Bowes confirmed this statement and added that currently what is authorized is the \$9,352,000 and that is what is being amended tonight.

Councilor Fishbein stated firmly that this language does not state that.

Mr. Bowes said this is how it has always been done, and there has never been any interpretation that this is an additional \$13 million on top of the \$9 million. He said that this will wipe out anything that said \$9,352,000 prior to tonight and replaces it with \$13,352,000. It is the authorization to spend an additional \$4,000,000.

Councilor Fishbein said that he understands the intent but that is not what this says.

Mayor Dickinson said that the current title is for \$9,352.000, and in the body of the ordinance, it describes that the title amount of \$9,352,000 is being amended to reflect \$13,352, 000 with the addition of \$4,000,000, Section I of the ordinance.

Councilor Fishbein seemed to be satisfied.

Councilor Sullivan commended Chairman Brodinsky and the Committee along with Mr. Stein and Mr. Tyrone. He acknowledged the countless hours that have been contributed to the project. Chairman Parisi echoed for the entire Council what Councilor Sullivan said.

Councilor Fishbein asked about the funds that have been expended. Mr. Brodinsky said that \$9.8 million has been spent and been spoken for. He said that there is no 'budget'; the bids come in and are approved, and then the bonding funds are used to pay for the work. Mr. Brodinsky continued that if the bonding money proves insufficient, then the committee comes back to the Council for more bonding money. Bonds are not sold if all of the funds that are authorized are not used.

Councilor Fishbein asked about Phase 1 where it seems that the committee is over-budget under the current bonding authorization of \$9,352,000. Mr. Brodinsky said no because there is no budget. He added in response to Councilor Fishbein that solar will be installed in 2013.

Councilor Fishbein wanted to know about DEEP funds awarded to the town as a result of a violation of emissions in town. A letter went to the state asking that the award, or part of it, be applied to an energy project. He said he asked this be done in a prior discussion about solar projects at the schools related to energy conservation projects. The Mayor has not had a response to his letter to DEEP but will look into this further.
