5. PUBLIC QUESTION AND ANSWER PERIOD

Tom Meizzi, 18 East Dayton Hill Road, said that he thinks Councilor Economopoulos is doing an excellent job. Next he commented on the length of time that that Center Street Cemetery can be used. He predicts its life to be ten years. With that in mind, he does not agree with the acquisition of large machinery or the purchase of adjoining properties for use by the Cemetery Association. He also stated that you cannot sell the American Legion Building without an appraisal.

Bob Gross, 114 Long Hill Road, announced a public meeting for Dec. 11 with Covanta and Deep with regard to a Title 5 Permit that is being sought by Covanta. The meeting will be held in the Town Council Chambers. He confirmed with the Mayor that this announcement will also be posted on the town's website and on Government Television.

Larry Morgenstein, South Main Street, was seeking information on the status of the twenty-eight trees slated for removal by the town. Mayor Dickinson responded that Henry McCully, Director of Public Works, has met with the tree committee which was organized by Wallingford, Inc. He reported that they have agreed on two types of trees and are getting quotes. They discussed maintenance and other details.

Bob Gross to the Mayor asked about a town-wide garbage pick-up. Mayor Dickinson said that it is an ongoing issue and all sides must be looked at.

It was noted that the Public Hearing could not begin as it was not yet 7:00 P.M.

Councilor Fishbein arrived at the meeting.

6. Public Hearing at 7:00 P.M. regarding the Sale of 41 South Main Street.

At 7:03 P.M., Chairman Parisi convened the Public Hearing.

Ray Rys does not want the house to be sold.

Attorney Farrell stated that the court had placed certain limitations on what can be done to the house.

Joseph Gouveia, Whirlwind Hill Road, wished the prospective, new owners good luck with the project. He reviewed the history of the declining purchase price and the costs involved in the restoration of the house.

In attendance: Richard & Erin Benham, 221 South Whittlesey Avenue, Wallingford On display: A rendering of the house as prepared for Mr. Gouveia, except for the color of the building, by architect Daniel Lyon.

Councilor Fishbein was concerned about the appearance of the finished building appearance. Attorney Farrell noted that this contract is the same as it was for Mr. Gouveia when he proposed to purchase the house. He stated that the Council can add restrictions to the deed if they choose to do that. Councilor Fishbein said that he wants to see something in the deed. He said that he is concerned about this building and that it has been talked about yet there are no restrictions in the documentation.

Councilor Sullivan, speaking with the Benhams, asked about who drew the rendering on display. Mr. Benham stated that it was by Dan Lyon. They discussed the bump-out that they plan to remove. They talked about the porch. Councilor Sullivan said that this is somewhat a re-hash of the Gouveia presentation. They discussed the back of the building.

Wallingford Town Hall, 45 South Main Street

Councilor LeTourneau talked about the color of buildings on Main Street over which owners have control. He noted that the Council has only seen artist renditions of the way the restored building could look. He said he has no problem at all with incorporating the rendering into the documents. He added that it was the Attorney General's Office who gave permission to remove those parts of the building that were added after the building was originally built. The windows' placement must remain the same. He thinks that the Benhams will do a great job. The porch replicates an early 1900s postcard of the building.

Councilor Economopoulos stated that he will vote against this transaction. He said he is in disagreement with the Council's past actions towards prospective buyers.

Councilor Laffin said he trusts what the Benhams will accomplish, and he will vote for this transaction.

Councilor Fishbein said that he does not question the intents of the Benhams, rather he is trying to protect the taxpayers. He cares about the downtown. He asked if his understanding to incorporate the rendering as part of these documents is correct. The Benhams concurred.

Councilor Economopoulos believes that limitations and specifics better be in the contract.

Chairman Parisi made a statement that he trusts the Benhams and he said that they will take pride in this project.
