5. PUBLIC QUESTION AND ANSWER PERIOD

Robert Gross, 114 Long Hill Road, asked about Covanta, their taxes and assessment for the current year and in the future. He also wanted to know the tax structure for LS Power and equity stakes.

Larry Morgenstein, Main Street, asked about the Affordable Care Act and its impact on Wallingford. He was also interested in phosphorus mandates by the State of Connecticut.

James Hine, 342 South Elm Street inquired of the Mayor about permits with respect to Pat Wall Field.

6. Discussion and Possible Action regarding Choate Rosemary Hall's proposed acquisition of Beaumont Avenue – Mayor

Due to a business relationship with Choate Rosemary Hall, Councilor Mansfield recused herself from the discussion and any subsequent votes. She stated that Choate are an active business client and that she has asked the Ethics Commission with regard to any future participation.

In attendance: Alex Curtis, Ph.D., Headmaster, Choate Rosemary Hall Joan C. Molloy, Attorney, Loughlin Fitzgerald, 150 South Main Street, representing Choate Rosemary Hall

Dr. Curtis and Attorney Molloy were welcomed to the meeting by Mayor Dickinson. Attorney Molloy handed out drawings of locations of the buildings under consideration with this project. She reviewed the project history recounting changes in the plans after meeting with neighbors in the area of the project. She reviewed this with the assistance of large boards of the same drawings the Council received (*also part of the record of the meeting*). Attorney Molloy noted that Choate determined that its student activity center did not meet the needs of they wanted to provide to the students. In addition, she said that the school does not have an auditorium that is large enough to allow the faculty, staff and students to meet as one body. There have been preliminary meetings with both the neighbors and with the Mayor that have resulted in the second design that seems to be satisfy all parties. She said that they have established that they will need approximately one hundred feet of Beaumont Avenue, not the whole road.

The Council discussed some of the options they would like to see entertained in any negotiation that occurs with the Mayor and the school. One option included the Boat House on Lake Street. It was determined that discussions with the Council cannot be considered in an Executive Session; however, Corporation Counsel, Janis Small said that she would review the statute again.

Rob Blanchard, Curtis Avenue, complimented Choate Rosemary Hall for the plan revisions but shared some concern about future development following this project.

Geno Zandri, 9 Balsam Ridge Circle, said he thinks the town doesn't need to road and is in favor of Choate Rosemary Hall having the road. Councilor Laffin read Attorney Martha Triplett's letter into the record. Attorney Triplett is a Beaumont Avenue neighbor.

There was some discussion of utilities and of a utility easement to Choate but specifics were not discussed since the utilities location, etc., are an unknown at the point in time. One Councilor mentioned leasing. Mayor Dickinson stated that Assessor Jackson's office would value the property.

Chairman Cervoni noted that Attorney Triplett was okay with the discussion as long as no decision was made tonight. Attorney Triplett's attorney who was in attendance, confirmed that to be correct.

He discussed the project and said that they were only able to apply for a certain amount of funding in 2012 and that now the project needs to be completed with new funding.

Robert Gross, 114 Long Hill Road, asked about the town's application to this particular grant and how many in the past. Mr. Roe recalled the Railroad Station. Mr. Gross would like to see an application made every year.

Chairman Cervoni closed the Public Hearing at 8:17 P.M.
