The Regular Meeting of the Wallingford Town Council was called to order at 6:33 P.M. The Opening Prayer was given by Pastor Will Marotti of the New Life Church of Wallingford. Geno Zandri, 9 Balsam Ridge Circle, spoke about an accident on Cook Hill Road caused by a bad portion of the road. He offered a suggestion of a way to repair it.

Robert Gross, Long Hill Road, asked about ownership of the Pierce Power Plant land and who benefits from the agreement with CMEEC. In regard to the budget, he asked the Council to review the lease with CMEEC.

Larry Morgenstein, no address given, commented on the process of the appointment of Jean Pierre Bolat to the Board of Education.

Gina Morgenstein, no address given, asked about the Council's Rules of Procedure.

Ken Daly, 594 North Elm Street, spoke about accountability for entities that receive funds from the town. He suggested a memorandum of understanding between those entities and the town, which would improve communication.

Chairman Cervoni explained that this item will come back before the Council at a later date. He offered that melting snow revealed some issues with the property that need to be addressed first.

9. Discussion and Possible Action authorizing the Mayor to sign Interconnection Station Agreement Between the Town of Wallingford Department of Public Utilities Water Division and the South Central Regional Water Authority – Public Utilities MOTION TO APPROVE authorizing the Mayor to sign Interconnection Station Agreement Between the Town of Wallingford Department of Public Utilities Water Division and the South Central Regional Water Authority. MADE BY: LAFFIN SECOND: PARISI

Councilor Mansfield announced that she is recusing herself from this question as South Central Regional Water Authority is a client of hers.

In attendance: George Adair, Director, Public Utilities

Mr. Adair stated that the PUC is seeking authorization for the Mayor to execute a contract with South Central Water Authority. This twenty-year Agreement with some evergreen renewal clauses covers all of the terms and conditions related to the construction, maintenance and operation of this facility on Pond Hill. It also includes provisions whereby either party could sell to its counterparty up to one million gallons a day of water. The entire document is based on emergency only use of this facility, and that it is not intended, and does not contain language, to address long-term use over extended periods for regular water supply. This is the second Agreement related to this project. There was prior action to approve purchase of the land, and the Regional Water Authority has now paid its share of that cost. We now need this second Agreement in place to cover all of these terms and conditions.

Councilor LeTourneau announced his opposition again to the location of this pumping station. He spoke about how things seem to change. He spoke of the cost-sharing in the second Agreement. He asked whose emergency is it? Wallingford or South Central? Mr. Adair said yes to both and said that is why there is cost-sharing. Mr. LeTourneau stated that he still thinks this will become a full-time pumping station.

Councilor Fishbein stated that he has some of the same concerns. There was discussion that if South Central Water Authority makes a request for water, they turn it on. It requires no 'approval' for that to happen. Metering is read by both parties. Who defines 'emergency' and where is that in the agreement? The term is not spelled out in the document.

Stated in the beginning (Page 1 of 7) of the Agreement on Line Nine (9) is the phrase "as needed on an emergency basis..." and on Line Eleven (11) the phrase "interconnection as needed...". Why is "emergency" not in Line 11? A suggestion was made by Town Attorney Farrell, and accepted by Councilor Laffin as a friendly amendment, that "on an emergency basis" could be added to the Agreement at Line 11.

But after further discussion **Councilor Laffin made a motion to table the issue. Councilor LeTourneau seconded.**

Councilor Fishbein raised a Point of Order to name another time when this question will be taken up again. Chairman Cervoni stated that he is a little less concerned since the PUC will come back before the Council. He called for the vote.

> Councilor Fishbein stated that during this term, he has acted as Chairman of the Ordinance Committee and has had a difficult time in having a quorum for meetings. Currently the Rule is that because the Council is a body of the whole Council that the quorum is five Councilors and that has been difficult to attain. He said that we do have business to conduct and department heads are relying on the Ordinance Committee.

11. Discussion with regard to the *Connecticut School Health Survey*, 2013 Results for Wallingford - Chairman Vincent Cervoni and Councilor John Sullivan

In attendance: Councilor John Sullivan Craig Turner, Director, Youth and Social Services Department Celeste Jorge, MPH, Epidemiologist, Connecticut Department of Health

Councilor Sullivan at the presentation table stated that he appreciates Chairman Cervoni sponsoring this item with him. He said that this survey came to his attention through a colleague on the Board of Education. He remarked that the survey hit him hard. He commented that it reflected to him that we have a parenting issue at home. Bringing this forward at a Council meeting allows talking to all of our parents who have children in Wallingford school system. He said that this is no reflection on the school system itself but that it was done through the cooperation of the school system.

Mr. Turner and Ms. Jorge narrated the slides. (*The slides are part of the record of the meeting.*)

The slides and presentation addressed the statistics gathered from the survey comprised of two components: Youth Behavior Component and Youth Tobacco Component. The Youth Behavior Component of the Connecticut School Health Survey was administered with parental permission at both Wallingford High Schools in the Autumn of 2013. The survery was developed by the Centers for Disease Control and Prevention and is known as the Youth Risk Behavior Survey and was refined by both the state and local-level representatives.

Ms. Jorge spent the better part of an hour reviewing the statistical details of the survey categories which included the following: General Health Motor Vehicle Safety Injury and Violence Alcohol Use Substance Use and Abuse Sexual Behaviors Obesity, Overweight and Weight Control Protective Factors Family Connectedness School Connectedness Academic Factors Other Risky Behaviors (gambling)

She also spoke about least risky behaviors involve students with good grades whose parents know where their children are when their children are not at home, and secondly, parents and children who eat their meals together.

Mr. Turner said often deficit behavior shows up in Grades 10, 11 and 12 but that it really begins in Grades 6, 7 and 8 for those students. He said that structure needs to be set early.

The panel was thanked for the presentation and for their time.
