### In attendance: Kacie Costello, Town Planner Don Roe, Program Planner

Councilor Fishbein addressed his reasons for removing this item from the Consent Agenda. He stated that he is aware of the Incentive Housing Program and that he is also aware that to his knowledge the town doesn't own any property adjacent to where the new train station will be located, so that he is trying to understand this item.

Mr. Roe said the town has been immersed in the high-speed rail project in attempt to minimize negative impacts to the community. In talks with the State, it was identified if the state would provide funding to evaluate what potential the high-speed rail could have. In September 2014 the State announced that they were making funds available and requested applications. This item is to apply for funding to do a Transit Oriented Development (TOD) study to see what would fit and what would not fit in terms of figuring out how to attract capital investment that would link the station to downtown. The station is now on the extreme edge of downtown and the effort is in

trying to bridge it to downtown and to create a better relationship to increased rail service with downtown businesses.

Councilor Fishbein asked if he was to understand that the potential impacts are limited to the effect of the high-speed rail coming through or is it in conjunction with the IHZ?

Ms. Costello stated that currently the Council of Governments with separate funding is studying from a macro point-of-view in its member towns that have stations along the New Haven-Hartford-Springfield line what the potential is for transit-oriented development is. They are looking within a one quarter mile radius around those stations. We will get a report indicating the existing conditions within that radius and the general potential for TOD. What they are proposing to do with this grant, working with a consultant, is to determine how that potential for TOD might be implemented, specific actions that the town might take or specific changes to the regulations. She said it would expand the radius to one half mile around the southern platform of the new train station, and it then would incorporate the IHZ within that. It would consider the IHZ as one of the elements but it will also be looking at the regulations with regard to Route 5 and North Cherry Street. There lots of different zones in that area so zoning might be looked at. It would incorporate IHZ but it wouldn't be limited to that. It would take the downtown focus and that would be an element but really it's looking at TOD around the train station's southern platform.

Mr. Roe offered that the starting point is how to figure out to get capital investment into the downtown, how to make that a financially feasible area for people to invest in. He noted that the Resolution does not name an amount of money. In doing due diligence to determine the cost of a consultant, he said that the folks that are in this business are not the kind of consultants that the town has any experience with. Upon inquiry with COG and Meriden, they pointed to \$75,000. The State's minimum application amount is \$50,000.

# 10. Report and update from the Health Department Director on public health for the upcoming winter flu season – Councilor John LeTourneau

In attendance: Eloise Hazelwood, Director of Health

Mrs. Hazelwood reported that the flu season runs from September to May. She stated that flu is a reportable illness. She gave some statistics and said that this will not be a bad flu season. She said they follow CDC Guidelines and that she meets weekly with Wallingford's Emergency Medical Service.

Assistant Superintendent, Cindy Lavalette, reviewed the seventy-one (71) member Wallingford Education Secretaries Negotiation highlights (*part of the record of the meeting*). She talked about insurance deductible increases, an increase in premium cost shares, a sunset waiver out of contract, a reduction or sunset on longevity and severance, a move to bi-weekly paychecks and holding salary increases to two percent or less.

There were no comments or questions from the Town Council. Robert Gross, 114 Long Hill Road, was interested in the cost/savings to the Board.

Councilor Parisi was acknowledged for attending all of the negotiations as Town Council Liaison. He said he was impressed with how the negotiations were handled and conducted. He thanked everyone. There were no comments or questions from the Public.

## 8. Discussion and Possible Action regarding *Wallingford Education Association Teachers Contract* from September 1, 2015 to August 31, 20217 – Board of Education

In attendance: Dr. Salvatore Menzo, Superintendent of Wallingford Public Schools Cindy Lavalette, Assistant Superintendent, Personnel Roxane McKay, Chairwoman, Board of Education

Assistant Superintendent, Cindy Lavalette, reviewed the highlights of the *Wallingford Education Association Teachers contract*. She talked about insurance controls; premium cost share increase; third year re-opener; insurance waiver reduction; sunset waiver; reduction of bereavement and family illness days; and holding the salary increase to 3% plus step over two years with a third year reopener. The WEA is a 570 member union of whom 322 are at the top step.

This discussion had many comments from the Council, most of whom did not like the agreement but said at the same time that they would support the negotiation with a yes vote. Councilors want to avoid arbitration. They are worried about the tax impact to their constituents. The hard work of this negotiation was acknowledged.

Dr. Menzo noted the \$9,000 loss to some families due to the change in insurance reimbursement. He also said that he feels teacher evaluations will lead to more innovation. He said that the Board had looked at lay-offs. There was complaint on the true nature of the raises by the time step increases, etc. were added to the base raise. One councilor said that this is a crisis that can't be dealt with again.

Resident, Rob Fritz, Robert Gross, Wes Lubee, Paul Ciardullo all spoke to this question.

Wes Lube, Montowese Trail, asked about process. These are funds to hire an architect to make a design that will be a biddable document so that it can go out to bid. Peter Gouveia, President of the Center Street Cemetery Association, made comments. He reported that they will go ahead even if they don't get the state grant.

Councilor Parisi left the meeting at 9:15 P.M.

The Mayor pointed out another advantage, that of being able to keep the bookkeeping for one project, such as this, all in one place. We are eligible and hoping for a grant.
