Chairman Cervoni read the Title of the Ordinance and Section 1.

AN ORDINANCE APPROPRIATING \$2,270,000 FOR THE LYMAN HALL HIGH SCHOOL TRACK AND FIELD PROJECT AND AUTHORIZING THE ISSUE OF \$2,270,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE

Section 1. The sum of \$2,270,000 is appropriated for planning, acquisition and design of the Lyman Hall High School Track and Field Project including the construction of an eight lane running track (to replace a current 6 lane track) and an all-weather, multi-sport artificial turf athletic field, including drainage systems, fencing, bleachers, lighting fixtures and electrical systems, ADA and safety compliance issues, storage facilities, so much thereof or additional improvements as may be accomplished within such appropriation (the "Project"). The appropriation may include expenses for appurtenances, equipment and services related thereto, alternative methods to achieve the indicated improvement, contingency, demolition, appraisal, testing, environmental remediation, surveying, insurance, administrative, advertising, printing, legal and financing costs to the extent paid therefrom. Said appropriation shall be in addition to all prior appropriations for said purpose, and inclusive of state and federal grants in aide thereof.

Chairman Cervoni asked for comments from the public.

Robert Gross, 114 Long Hill Road, through the Chairman, asked the Comptroller if the Town would be bonding. Comptroller Bowes said they would be and that it might be part of a package that could include some of the school roof project, a water tank for the Water Division, school boilers among other town projects. He would not commit to an interest rate as they have been fluctuating.

There were no more comments from the public.

The Public Hearing closed at 7:13 P.M.
