MINUTES

The Swearing-In Ceremony of the Wallingford Town Council and the Wallingford Board of Education took place on Monday, January 4, 2016 in the Robert F. Parisi Town Council Chambers in Town Hall, Wallingford, Connecticut.

Mayor William W. Dickinson, Jr. called the Ceremony to order at 8:02 p.m. and welcomed everyone.

1. The Call to Post the Colors was made by Roy Cannon, Post Commander, American Legion Shaw-Sinon Post #73.

2. Invocation:

The Invocation was made by the Rev. Dean Warburton, First Congregational Church.

3. Pledge of Allegiance:

4. Swearing in of Mayor William W. Dickinson, Jr.

Mayor William W. Dickinson, Jr. was sworn in by Judge of Probate Philip A. Wright, Jr.

5. Remarks by Mayor William W. Dickinson, Jr.

Mayor Dickinson, in his remarks, congratulated all elected officials and noted they were entrusted with the management of the affairs of the Town which is an important task. He said tonight was a solemn, humbling and joyous occasion. He said there is no simple answer to the

8. Mayor Dickinson Presiding at Election of Town Council Chairman

Mayor Dickinson opened the floor for election of the Town Council Chairman.

Thomas Laffin nominated Vincent Cervoni for another term as Chairman of the Town Council. Mr. Laffin said Mr. Cervoni has served as Chairman with incredible dignity and a calm which he admires. Counclor Laffin said Chairman Cervoni has had tremendous shoes to fill, and noted he previously served as Council Vice-Chairman. Councilor Laffin said Chairman Cervoni's strength lies in two areas: his dedication to Wallingford and dedication to do what is right and avoid pettiness, just wanting the best for Wallingford. Councilor Laffin said Chairman Cervoni has the ability to be a strong teammate, partner, and at the same time, a strong leader, and doesn't set himself above us on the Council. Councilor Laffin said Chairman Cervoni brings everyone together as a harmony of nine partners, teammates and public servants, together for the same reason, a better Wallingford.

Councilor LeTourneau seconded the nomination. He said he has watched Chairman Cervoni grow in his position from Vice-Chairman to Chairman and has done a great job and he sees this job and his patience and leadership continuing.

9. Remarks by Town Council Chairman

Chairman Cervoni thanked his fellow Councilors. He said while honored, this is an obligation he doesn't take lightly and noted this term begins with many concerns; a global economy and challenges imposed by the State and Federal governments. He said he remains hopeful, noting that Wallingford is a great town with a great future. He made reference to a thriving business economy in town and a great school system. He spoke about the Incentive Housing Zone which he said will enhance the area surrounding the new train station. He said he hopes the Council is able to turn this opportunity into another jewel in the crown of Wallingford. He said the Council will have to work together, work through disagreements and "color outside the lines" and reach compromises and has confidence this Council will accomplish much in the next two years.
