Councilors asked for more information on holiday pay, health insurance co-pays and the new light duty program.

Councilor Fishbein questioned retroactive pay from July 1, 2016 and asked from what budget it will come out of.

Mr. Hutt responded that he did not have a figure and indicated that this is in his budget.

There was discussion between councilors and Chief Wright regarding the use of an officer at the corner of Main Street and Center Street.

The majority of councilors approve of the police presence downtown.

Councilor Sullivan stated he had discussions with Chief Wright and crime statistics are down. He also had conversations with officers and morale is high. He then went on to say this is a good contract.
