Christina Tatta, 71 N. Farms Road, stated that she was upset about the PUC Commission again coming up in an editorial. 7. Discussion and Possible Action regarding draft explanatory text and the number of Charter ballot questions – Chairman Cervoni

Chairman Cervoni stated that the quality and variety of recommendations are a good product from the Commission and he hopes it would be a one ballot question.

Councilor Fishbein commented that he did not see in the minutes that the Commission recommend one question and then asked Attorney Small where she got that comment from.

Attorney Small responded that her advice to the Commission was that they have no say in if it will be one question or not, but their conversations throughout have all revolved around only having one question on the ballot.

Chairman Cervoni invites the Charter Chair, Stephen Knight, and the Vice Chair, Christina Tatta to the table and asks them to please address the presumption of Attorney Small and the one question item.

Mr. Knight stated over the course of time, their goal was to produce a document that modernizes the Charter and gives the voters a document that did not contain any severe governmental structured changes. He went on to say that the Commission wanted a document that would not be controversial and could be presented as one question.

Mrs. Tatta stated that she agrees with Mr. Knight and went on to say that their work was to help the voter get to understand the changes simply.

Councilor Shortell thanks everyone. He then stated to Mr. Knight and Mrs. Tatta that he does not recall reading in the Charter Commission minutes about anyone coming to their meetings questioning them about putting the questions on as individual questions. Mr. Knight responded no, no one did. Councilor Shortell says he is open to either way.

Councilor Sullivan asks if it was the Commission's charge to come up with a single ballot question and Mr. Knight answered no and stated general consensus was to have a single ballot question.

Councilor Zandri worries that the voters will vote it down because they don't like one issue and Mrs. Tatta remarked that she thought about the same thing, and thought that would be a small percentage.

Councilor Laffin stated that he thinks it will be a small percent who are confused and he supports one question. He commented that Councilor Fishbein wrote a great breakdown but it's confusing to the voters. He doesn't see anything controversial enough to not do one question.

Councilor Marrone stated that he's not that passionate one way or another but he is concerned that crunching it into one question isn't a great idea. He thinks voters are smart enough to know what they are voting on.

Councilor LeTourneau stated that he supports Councilor Sullivan's Motion. He stated that we need to get the word out on what the voters are voting on.

Councilor Fishbein asked if the Commission discussed the issue of one question and stated that he doesn't want to see the whole thing go down in flames. He then stated if this question passes, the Town Clerk will work for the Mayor and not the Council. He doesn't agree with the fact that the Council already gave up their staff.

Councilor Fishbein remarked that we have a small controversy over the Environmental Planner. He stated that any of these questions with explanatory text can blow up the question.

Councilor Laffin stated that he is extremely comfortable with the Clerk running the Council office. He went on to say that the Councilors knew when she took it on that it might be temporary but they have been very lucky that she and her staff can get the work done.

Councilor Sullivan stated he thinks we have the best Town Clerk and hopes she stays a long time but when the time comes, the Mayor, whoever that is, should hire the most qualified person for the job and not be appointed by the Council.

## PUBLIC COMMENT

Pat Kohl, 50 North Street, Member, Charter Revision Commission, stated that they incorporated most of 2009 questions into their revision and they would like one question.

Darryl Stancuna, 18 Old Village Circle, suggested sending this proposal out to the public first along with the electric bill.
