The Meeting of the Wallingford Town Council on Tuesday, October 24, 2017 was called to order at 6:41 P.M. There was a moment of silence and the Pledge of Allegiance was said. Councilors in attendance were: Chairman Vincent Cervoni, Craig Fishbein, Thomas Laffin, John LeTourneau, Christopher K. Shortell, John J. Sullivan and Vincent Testa, Jr. Councilors Joseph A. 5. **PUBLIC QUESTION & ANSWER PERIOD**

Opened Public Question & Answer Period at 6:45 p.m.

Wayne Gilbert, 44 South Cherry Street, stated that he is here to speak against the new change to the pension plan. He remarked that the town cannot afford it and the current fund cannot sustain it. He urges it to be voted down.

Mayor Dickinson indicated that the speaker is a union staff representative. Mr. Gilbert responded that he is not a staff representative and that he is retired. Mayor Dickinson then stated that the record should be clear that Mr. Gilbert is a representative of the Bargaining Unit.

Jonathan Chappel, East Dayton Hill Road, spoke about Charter Revision and the proposed provisions regarding the ability to remove elected officials.

Bob Gross, Long Hill Road, explained you do have the power to remove appointed positions and referred to Section 9 – Chapter II. He stated they are removing it all and went on to say that most towns have some provision to remove appointments.

Mr. Chappel stated that requiring an ordinance would also require a public hearing.

Mr. Gross stated that public hearings were not always well attended.

Mrs. Hand explained that the Public Act became effective October 1st of this year allowing Temporary Healthcare Structures to be placed on individual properties. In Wallingford we have many accessory apartments so we do not feel we need to comply with the Public Act. We may look to expand our accessory apartment rules and we are in the process of looking at them. Planning & Zoning at its last meeting voted unanimously to opt out of this legislation as it is written so all we need is your vote as a legislative body to also opt out.

Councilor Fishbein is concerned that he received the Resolution the day before the Council meeting and it is revolved around politics and not good intentions. He explained that he supports portions of this language but he does not support attacking the Marino Bill which he does not think exists. He cannot support this.

Councilor Sullivan thought we would keep politics out but obviously not. He stated he supports this absolutely.

Mayor Dickinson commented that the DEA saw imminent danger in the flow of drugs and it curtailed their ability to do their job.

Councilor LeTourneau remarked that this is a difficult subject. He stated this Resolution is a help and he has a vested interest in this. He explained that he had a daughter who died of an overdose of oxycodone and her five year old son sat next to her and watched. We are at war with these drugs. It has to stop. He stated there is hope and the coalition and the police are doing great work but everyone today needs to do more.

Councilor Zandri wants to emphasize his support for this organization and noted we need everyone to help.

Councilor Testa stated that he is talking to these kids every day in school and trying his best to help.

Chairman Cervoni stated that he did some research and compromised the wording in the Resolution with the congressional candidates and softened it.

9. Discussion Regarding a new town-wide emergency and departmental radio communication project - Police Chief and Fire Chief

In Attendance: William Wright, Police Chief Mark Mikulski, Deputy Police Chief Richard Heidgerd, Fire Chief Joseph Czentnar, Deputy Fire Chief

Chief Wright presented that they are looking to purchase a two-way radio system that would include police, fire, public works and the school system. He stated they have been discussing this for the past 18 months and that currently the school system is not in that loop.

Councilor LeTourneau stated to Chief Wright the he provided a comprehensive report. He commented that he likes that it eliminates the dead zones and includes the schools. He then asked why not go out to bid and why Motorola?

Chief Wright stated all the corresponding departments already use Motorola plus they are the premier two-way system and we are not willing to have an inferior communication system. He explained that we also have a long standing relationship with Motorola. In order for us to go out to bid we would have to hire a consultant to write the specs and we do not have that expertise but our current vendor has done that for us.

Councilor Fishbein asked if there are any similarly sized towns that have gone out to bid that we could use their specs.

Chief Wright responded yes there have been and they have come in very close to the prices we are looking for, but each town has its own specifications and we wouldn't want to miss anything by copying another town's bid.

Councilor Sullivan asked what the life cycle is of these radio units and Chief Wright responded typically 15 -20 years. Councilor Sullivan then asked if the maintenance contract is a separate agreement and Chief Wright responded yes.

Councilor Sullivan asked the Mayor if this is something we would bond and the Mayor responded that the expectation would be to bond this.

Chairman Cervoni asked how you go from four towers to five towers topographically. Chief Wright responded that Chief Heidgerd and his men have worked very hard to make sure that they have had no drop spots anywhere. They did a lot of boots on the ground testing and making sure that the shoulder mics worked.

Councilor Testa stated that he is happy to hear that we are going to have an instant communication system between police, fire and the school system and he thinks that they have justified their need for a bid waiver.

Councilor Shortell wants to confirm that there will be an 18 month delay if we did not pass the bid waiver. Chief Wright clarified that we would have to hire a consultant to do the specs and that would take around 18 months. He stated that we would then have to go out to bid so the delay would be about two years.

Councilor Zandri stated that he is comfortable with waiving the bid for this and for bonding for this purpose. This is exactly what we should be bonding for.

Chairman Cervoni called up Christina Tatta and Jonathan Chappel from the Charter Revision Committee.

Mrs. Tatta stated that we as a Commission would like to have everyone informed on what the question means when they go to the polls so we would hope that the town would put the explanatory notice in the paper. Mr. Chappel stated it's just a one page summary that's informational.

Councilor Testa asked that we link the town website in the ad because it has the full redline version on the website.

Councilor Sullivan stated he knows that Barbara will do the right thing and get it in the paper the right way.

Pat Kohl, 50 North Street, is in favor of getting this out. She does not want people to be misinformed.
