# SPECIAL TOWN COUNCIL MEETING

## WEDNESDAY, FEBRUARY 16, 2000

## <u>5:30 P.M.</u>

A special meeting of the Wallingford Town Council was held on Wednesday, February 16, 2000 in the Robert Earley Auditorium of the Wallingford Town Hall and called to Order by Chairman Robert F. Parisi at 5:45 P.M. Councilors Brodinsky, Knight, Papale, Parisi, Rys and Zappala answered present to the Roll called by Town Clerk Rosemary A. Rascati. Councilor Centner was on vacation; Councilor Farrell was detained due to an unexpected maintenance problem at home; Councilor Vumbaco was also on vacation. Mayor William W. Dickinson, Jr. was present.

The Pledge of Allegiance was given to the Flag.

ITEM #2 Discussion and Possible Action Regarding Approval of a Pension Plan Tentative Agreement with AFSCME Co. 4 Local 1183, 1303-060, 1303-062, 1303-173, CSEA Local 760 and the Health Service Professional Association - Mayor

Mr. Parisi reminded the Council that no vote is, in essence, accepting the contract.

Terrence Sullivan, Personnel Director gave a brief overview of the plan. He pointed out that the agreement involves about 305 employees and is a ten year plan retro-active to February of 1999. The changes in the plan includes changing the normal retirement definition from age 62 and 15 years to 10 years of service, which is consistent with the movement we have made with other units of this kind. Along with that we have agreed to reduce the early retirement penalty by half; if you leave early, for every month you have left early, you lose .25% off the pension. That again, is consistent with what we have done with other units. The spouse definition includes language that indicates that if a spouse of an employee covered by this plan dies while in service with the Town and they are less than 50% financially-dependent on that employee, they would.....let me say that right; if they were more than 50% dependent upon their spouse for financial purposes, they would be covered. Again, we have been changing that language to be consistent with other contracts. What I like most about this contract is the limited changes in benefits and the cost to the Town; it is very, very minimal. We are saying it is about one-half of one percent of payroll and arbitrated pension awards have averaged 2 1/2 - 2.6%. It is also a ten year agreement, which is nice to lock it up for a period of time. Normally, we lock it up between seven and eight years.

Robert Sheehan, 11 Cooper Avenue asked which unions are affected?

Mr. Sullivan explained, it affects five Board of Education unions and Local 1183 which is Public Works, clerical and Sewer unit on the Town's side.

Mr. Sheehan asked, with this agreement, will the Town have to make a contribution to the Pension Fund this year or are we going to get another free year?

Mr. Sullivan answered, this agreement does not change the funding very much. It is going to cost the Town some but we don't anticipate, at this time, a contribution to the Pension Plan.

Mr. Parisi asked what the Council's pleasure was? Did they want to vote or allow it to be?

Those Councilors present did not indicate a desire to vote.

Mr. Sullivan stated, as far as the forty-fourth day, by law, it becomes a contract if there is no vote.

Mr. Parisi asked, is it important for you (Mr. Sullivan) that we vote or not vote?

Mr. Sullivan answered, not at all.

No action taken.

ITEM #3\_SET A PUBLIC HEARING for March 6, 2000 at 6:30 P.M. to Consider and Act Upon an Ordinance Amending an Ordinance Appropriating \$140,000 for the Design of a Senior Center and Authorizing the Issuance of \$140,000 Bonds of the Town to Meet Said Appropriation and Pending the Issuance Thereof the Making of Temporary Borrowings for Such Purpose (The purpose of the amendment is to increase the appropriation and bond authorization therein by \$3,321,000 from \$140,000 to \$3,461,000 to provide for the construction of the senior center, and to ratify, confirm and adopt all prior authorizations and ordinances in connection therewith.)
